

MY RESPONSES - 6-5-06

23 MAY 2006 RE: THE NOTES ABOUT SHAY ALLEGATIONS

THE COPY OF THE HANDWRITTEN NOTE BY ME TITLED "JAN 5 1993 MEMO - MEETING W SHAY JR 15 DEC 92" REFLECTS A MEMO FROM PAUL KELLY TO, I BELIEVE, NANCY GERTNER AND POSSIBLY RICHY SEGAL REGARDING A MEETING AUSA PAUL KELLY HAD WITH SHAY JR THAT OCCURRED ON 15 DEC 92.

I BELIEVE THERE IS A SUBSEQUENT MEMO WHERE THE TOWER NEAR A STUCCO BUILDING STORY WAS FOUND TO BE FALSE.

THE GOVERNMENT TOOK A 6" X 6" PIECE OF CARPET FROM THE TRUNK OF MY TOYOTA WHICH TESTED NEGATIVE FOR DYNAMITE.

THERE WAS TESTIMONY DURING SHAY'S TRIAL THAT HAD HIM AT A HALLOWEEN PARTY IN QUINCY FROM 6 OR 7 PM UNTIL AFTER 12 AM ON SATURDAY NIGHT OCT 26 1991 (GOVERNMENT THEORY WAS SHAY AND I AFFIXED THE BOMB TO SHAY SR'S CAR WHILE IT WAS DOUBLE PARKED ON SHAWMUT AVE 7-830 PM ON OCT 26) DAVID MILLETTE AND JOHN CARES BOTH TESTIFIED I WAS AT A PARTY IN DORCHESTER FROM 6-2 AM ON SATURDAY OCTOBER 26 AND REMAINED WITH CARES UNTIL I DROVE HIM TO WORK ON MONDAY THE 28TH.

I NEVER TOOK SHAY JR TO ANY WORK SITES, I ONLY GAVE HIM RIDES FROM BOSTON TO POINTS SOUTH, QUINCY ONCE, DORCHESTER ONCE, ATTLEBORO ONCE AND A RIDE 3 CITY BLOCKS OF BOYLSTON STREET.

1. I FIRST SAW THIS LETTER SOMETIME IN 1993 IN THE DISCOVERY MATERIALS
 2. I SENT MY RESPONSES TO IT TO RICHY SEGAL
- I'M NOT SURE, I'LL HAVE TO SEARCH MY RECORDS BUT I BELIEVE THIS WAS ONE OF THOSE MEETINGS JUDGE ZOBEL WOULD NOT ALLOW IN AS EVIDENCE. - CORRECT - ZOBEL STRUCK THE JUNE 11 1992 PROFFER

I ALSO THINK THAT THIS WAS ONE OF THOSE PROFFER SESSIONS THAT GENERATED A SUBSEQUENT MEMO FROM AUSA PAUL KELLY TO NANCY GERTNER STATING THAT NONE OF SHAY JR'S STATEMENTS COULD BE CORROBORATED.
