 CALLED AWAY THE TRUTH IS, I'M NOT DOING WELL
 IN PRISON THIS TIME. I'VE BEEN THREATENED,
 AND SEXUALLY ASSAULTED. MY CALL MATE
 MR. JAMES WOOD # 32013-086 WAS TOLD IF
 I DIDN'T COOPERATE IN AN INTERNAL INVESTIGATION
 THAT WOULD PUT MY LIFE AT RISK, THAT THEY
 WOULD MOVE MY CALL MATE. THEY MOVED HIM
 AND HE SAID THEN I WAS GOING TO KILL MYSELF
 I HUNG MYSELF FROM A SPEAKING. THEY SENT
 ME TO AN OUTSIDE HOSPITAL BUT PREVENTED THE
 HOSPITAL FROM DOING A PSYCHOLOGICAL
 EXAMINATION. WHEN I GOT BACK HERE, OTHER
 INMATES WATCHED ME FOR FOUR DAYS. THEY
 PUT ME IN S.H.U. 23 HOWEVER LOCK UP IN
 A CELL FARTHEST AWAY FROM STAFF AND I
 HAVE TOLD THEM MANY TIMES THAT I AM DEPRESSED
 BUT ALL THEY DO IS IGNORE MY REQUESTS TO
 TALK TO STAFF. YOUR HONOR, THE INTERNAL
 INVESTIGATION REPORTS AROUND GAMES AND
 THE PRISON CAMPUS. I WAS TOLD BY AN
 INVESTIGATOR, A MR. ROBERTS, THAT IF I
 GOT THEM FOR STAFF, THEY WOULD RELEASE
 ME THAT DAY. THEN ANOTHER STAFF MEMBER
 TOLD ME THE TRUTH. ONLY YOU CAN RELEASE ME
 AND NOT ONLY WAS MR. ROBERTS LYING TO
 ME, BUT HE WAS PUTTING MY LIFE IN
 DANGER AND LEAVING ME UNPROTECTED IN
 A CRIMINAL FASHION. SO I STOPPED.
 MAJOR, I HAVE 2 1/2 MONTHS LEFT IN FEDERAL
 CUSTODY BEFORE I GO TO WILSON FOR
 SIX MONTHS. (OVER)
