Dear Attorney Cosgrove:

The following is a narrative report concerning the injuries of Al Trenkler, sustained as a result of the above mentioned injury.

HISTORY OF OCCURRENCE

Mr. Trenkler stated that he was involved in a motor vehicle accident on 06/27/91 at 10:40 a.m. Mr. Trenkler was seated in the passenger seat of a vehicle which sustained impact in the rear. Immediately following the accident Mr. Trenkler stated that he began to feel dizzy and felt numb in his neck. Later that day he could not sleep. The next day he was not able to lift any weight with either arm and experienced pain when turning his head. On the first day consulted in this office, his present complaints were dizziness, neck and back pain and a vague generalized weak feeling of arms. The dizziness was intermittent occurring almost daily and of short duration. The neck pain was described as a moderately intense pain involving the entire cervical region with occasional spread into the right shoulder. The pain was made worse turning head in any direction. The back pain was described as a constant, achey tenseness and was made worse sitting, with difficulty sleeping. His past medical history is noncontributory as he denied any similar symptoms due to accidents, injuries or diseases prior to the accident.

DIAGNOSES

The patient's initial diagnoses was:

1. E812.0 Motor vehicle collision with another vehicle driver.
2. 847.0 Acute moderate hyperflexion-hyperextension injury to neck.
3. 729.1 Acute moderate cervical paravertebral myofascitis.
4. 780.4 Mild neuropathic dizziness.
5. 847.2 Acute mild-moderate lumbar sprain/strain.

CAUSATION

Upon completion of the consultation, history, current complaints, orthopedic, neurological, and radiographic examination, this data is consistent with the type of injury described by Al Trenkler.

TREATMENT

Treatment protocol has consisted of spinal manipulation and supportive therapy for alleviation of joint hypomobility, and it's associated ligamentous adhesions and muscle spasm. Intersegmental traction has been used to improve mobility and circulation in the joints of the spine. In spinal injuries or mechanical problems of the spine, the articulations or joints of the spine lose their mobility. Traction stretches the joint, causing a suction which helps the pliability or flexibility of the intervertebral disc. Traction also opens up the joint articulations and increases the circulation flow in the spine. Therapeutic exercises to promote the healing of tissues along functional ranges of movement. These exercises are designed to increase strength, improve flexibility and promote balance of the spinal support structures.

CONDITION

Has reached a medically stationary status.

LENGTH OF FURTHER TREATMENT

Mr. Trenkler's treatment has reached a point of maximum improvement. He is medically stationary and has been advised to seek treatment only if exacerbation occurs.

WORK STATUS

Mr. Trenkler was totally disabled from his occupation as an Engineer, which involved frequent climbing of ladders while carrying equipment, from 6/28/91 until 7/30/91 and partially disabled from 7/30/91 until 9/25/91.


REMARKS

It has been reported that once a person suffers from a musculoskeletal injury, he may likely suffer a recurrence of injury in the future. This may be due to the fact that soft tissue structures injured during sprain/strain traumas heal with scar tissue. Scar tissue is generally coarser and less elastic than the original tissue. Although Mr. Trenkler has reached a significant point of recovery, the entire ramifications of the injury remain uncertain. He may experience periodic symptatology with overuse or develop early degenerative changes within the spine.

4. 780.4 Neuropathic dizziness


