



At about 12:20 P.M. Monday, October 28, 1991 in response to a call for assistance regarding two injured police officers, I responded to 39 East Bourne St. Roslindale, accompanied by Sgt. Francis L. Evans, ID#6364 assigned to the E934D unit and an off-duty Boston Police Officer, Michael Parros, ID#8479. Upon arrival I was informed of the circumstances leading up to the injuries by Sgt. Thomas Creavin of District E-5. In conjunction with Captain William L. Parlon, ID#6283, ECO1, assumed command of the situation supervising the expeditious removal and transportation of the injured officers conducted by Health and Hospital personnel and the subsequent investigation and protection of the crime scene, mandating properly safeguarding the scene and the making of all appropriate notifications. 


Subject: Security and crowd control

Sir:

About 3:00 P.M. on October 28, 1991, I entered Area E District 18 station and was told there was a need for a Patrol Supervisor and a service unit immediately. As a result of this information P.O. Donald Wightman, assigned as the E608F (Motorcycle) and myself responded to 39 East Bourne St. Roslindale scene of a bomb explosion, where security barriers and tape were erected to secure the scene from numerous spectators and reporters.

About 4:10 P.M. requested additional service units via channel four. Responding to the scene was the E104F Officers Stephen Beatty and William Kendrick from District E-18. The E421F Michael Curry and the walking unit E675F Zanen Ramos from District E-5 also responded. The five officers were instructed by me to allow no unauthorized person into or beyond the police barriers erected in front of 39 and 35 East Bourne St. An officer was needed to secure the back yard of 39 East Bourne St. (crime scene) and was best accomplished from the yard of #35 East Bourne St. Due to the cold wind the officers were permitted to rotate this assignment on a half hour interval. Officers Wightman, Beatty, Kendrick, Curry and Ramos performed this assignment exaplary. I remained on the scene supervising security until relieved by the E923, Sgt. John Kryzanowski.




