9. DETAILS:

On 10/28/91 an explosive device detonated at 39 Eastbourne Street, Roslindale, Massachusetts. As a result of the explosion a Boston Police Bomb Technician was killed and a second seriously injured

Pursuant to this investigation, exhibits numbered 1 through 59 have been forwarded to the lab for analysis.

On or about November 15, 1991 one Russell Bonanno was interviewed by ATF Special Agents Henry Moniz and John Paolillo regarding his (Bonanno) residing with suspect Thomas A. Shay during the Month of September 1991 as well as intermitenly during the month of October 1991.

Removed from Bonanno's residence, 285 Old Westport Road, Dartmouth, Massachusetts were exhibits 60A and 60B, one roll of black electrical tape and one black tape holder/dispenser with a small amount of black electrical tape, respectively.

On or about November 20, 1991, one Richard Brown was interviewed by ATF Special Agents Thomas D'Ambrosio and Dennis Leahy at Brown's place of employment, ARCOMM, 82 Broad Street, Weymouth, Massachusetts. Provided by Brown for evidentiary analysis was exhibit 61, a Black and decker Cordless Glue Gun.

This report will serve to transmit exhibits 60A,B and 61 to the lab and to request that all pertinent forensic analysis be conducted. Lab analyst Cynthia Wallace, having participated in this investigation from the onset, can assist with any questions or problems as well as Group Supervisor Victor D. Palaza or Case agent Jeff S. Kerr, ATF Boston, Group 3 at FTS
