REPORT OF INTERVIEW				
With Mary Flanagan, by Special Agent Thomas E. D'Ambrosio, Special Agent Dennis Leahy and Detective Miller Thomas, Boston Police Department on November 13, 1991, 11:00 A. M. at ██████████				
Ms. Flanagan states as follows:				
She stated that Tom Shay (Sr.) was not afraid of anyone, prior to the bombing other than the two persons involved in the ongoing lawsuit at the Dedham Service Center. She said this was the basis for his apparent paranoia, which caused him to secure his basement door and install a motion detector on the house lights.				
She said that Shay (Sr.) has told her that he believes, that, if Tom Shay (Jr.) is responsible, he would have had help, possibly the person he knows in North Dartmouth. She said that Shay (Sr.) and Shay (Jr.) have not had much contact with each other recently other than by telephone. She did recall that Shay (Jr.) showed up at a bar recently where Shay (Sr.) was meeting others to go to the track and Shay (Jr.) ended up going along. She said that Shay (Sr.) has given Shay (Jr.) money on occasions. She stated that Shay (Jr.) is now, and always has been a bad kid, who does not know right from wrong and has no conscience. She said that to her knowledge, Shay (Jr.) has not been at 39 Eastbourne St. in the last 3 1/2 years since the theft incident. She stated that she remembers an occasion when Shay (Jr.) called and needed a place to stay. She said that she would not let him stay in her house and gave Shay (Sr.) an ultimatum. (Sr.) would also have to leave the house if he allowed Shay (Jr.) to stay at the house. She stated that Shay (Sr.) eventually gave Shay (Jr.) a ride to North Dartmouth.

Ms. Flanagan said that neither she nor Shay (Sr.) have a set routine for Sunday mornings. She said that on the Sunday morning before the explosion she went to church at 9:00am. She said that Shay (Sr.) had left before her to see a prospective customer. She said that when she returned from church Shay (Sr.) was not yet at home. She said that she then walked to Westbourne St. to collect money for the church and when she returned Shay (Sr.) had returned. She said that she again left with her daughter at 1pm to go to a Halloween party and did not return until 6pm and that Shay (Sr.) was at home at that time.

Ms. Flanagan stated that on the Saturday prior to the explosion she worked in the morning [REDACTED] left work at 2pm and went home to pick up her daughter to go to a birthday party in West Roxbury. She said that Shay (Sr.) was not at home when she returned in the early evening, but returned home shortly thereafter with Chinese food.

Ms. Flanagan stated that Shay (Sr.) does not have a daily schedule and is not currently earning any money. She said that she pays the bills and that they do not have any problems paying their bills. She said that Shay (Sr.) does not have any outstanding gambling debts. She stated that neither her nor Shay (Sr.) have wills, but they are in the process of having one made. She also stated that last night (November 12, 1991) she obtained life insurance on Shay (Sr.).

Ms. Flanagan also said that Tom Shay (Sr.) broke down the night of the Boston Police interview following the arrest of Shay (Jr.) when he thought that Tom Shay (Jr.) was possibly involved. Ms. Flanagan said that Tom Shay (Sr.) had visited Tom Shay (Jr.) at the Dedham House of Correction and that Tom Shay (Sr.) told her that he had told Shay (Jr.) to tell the truth, and that Tom Shay (Jr.)'s biological mother had also visited Shay (Jr.) at the House of Correction.

Ms. Flanagan also said that she never saw the bomb and that she had a "tiff" going with Shay (Sr.) so that he never told her about the bomb being in the driveway. Ms. Flanagan said that Shay (Sr.) never had hurt anyone and that she would know if he was lying. Ms. Flanagan also said that Shay (Jr.) loved the attention and that he feeds off being a celebrity.

Ms. Flanagan also said that Shay (Jr.) knew that she would not receive any money if Shay (Sr.) died but that his heirs, including Shay (Jr.) would.
