Report of Interview					
With Robert Thompson, 13 Rose Street, Stoughton, Massachusetts, On November 1, 1991, at approximately 7:30 pm, by Special Agent Allan Offringa and Sandra LeCourse, Bureau of Alcohol, Tobacco and Firearms.					
Mr. Thompson states as follows:					
Mr. Thompson stated that he was in fact is Robert Thompson, the same Robert Thompson that was arrested by ATF for firearms violations.					
Mr. Thompson stated that he heard on the television news, that two police officers had been recently been hurt by a bomb in Boston. Mr. Thompson further stated that he had no idea who would do such a thing.					
Mr. Thompson stated that the only explosives he ever had ware large fireworks and he would have no idea how to make a real bomb.					
Mr. Thompson stated that he did not know anyone by the name of Thomas Shay. Mr. Thompson stated that he would be willing to look at photographs to determine if he knew anyone from the area of his old neighborhood. Mr. Thompson stated that he did not know anyone who made bombs.
