9. DETAILS:

This report pertains to the investigation on the bombing that occurred at the residence of Thomas Shay Sr., 39 Eastbourne St., Roslindale, Ma. in which a Boston Police Bomb Squad member was killed and another critically injured. ATF, in conjunction with the Boston Homicide Unit, is currently investigating this matter.

On October 28, 1991 in the city Boston, Ma. on 39 Eastbourne St., an explosive device operated by a Futaba switch may have been set off by a transmission or reception frequency, which may have come from a NYNEX tower or a Cablevision dish located, approximately one half mile away, from the site of the detonation.

After interviewing the Managers from NYNEX and Cablevision on November 25, 1991 and getting the frequencies that they operate on. We want to determine if the frequency from the tower or the dish in fact could set off the device.

REQUEST: Determine if frequencies from a NYNEX or a cablevision towers, one half mile away, could activate and set off a Futaba switch.

1. The Futaba frequency has four transmission are: 75-72-52 Mhz and (27 Mhz which is the rarest).
