9. DETAILS:

This report pertains to the investigation on the bombing that occurred at the residence of Thomas Shay Sr., 39 Eastbourne St., Roslindale, Massachusetts in which a Boston Police Bomb Squad member was killed and another critically injured. ATF, in conjunction with the Boston Police Department Homicide Unit, is currently investigating this incident.

On or about December 5, 1991 Thomas Shay Sr. provided the Boston Police Department Homicide Unit with samples of wood that were located in his (Shay's) garage at 39 Eastbourne St.

This report will serve to transmit exhibit 65 to the lab and to request that all pertinent forensic analysis be conducted.
