9. DETAILS:

This report pertains to the investigation on the bombing that occurred at the residence of Thomas Shay Sr., 39 Eastbourne Street, Roslindale, Massachusetts in which a Boston Police Bomb Squad member was killed and another critically injured. ATF, in conjunction with the Boston Police Department Homicide Unit, is currently investigating this incident.

On or about December 5, 1991 Thomas Shay Sr. provided the Boston Police Department Homicide Unit with a sample of wood that was located in his, (Shay's) garage at 39 Eastbourne St. Two samples of this wood were forwarded to the lab on or about 12/09/91.

On or about 12/13/91, ATF Lab Analyst Cynthia Wallace requested that the remaining section of wood be forwarded to the lab for analysis.

This report will serve to transmit exhibit 66 to the lab as requested by Ms. Wallace.
