## 9. DETAILS:

## PROPERTY TRANSMITTAL

On January 31, 1992, Special Agent Thomas E. D'Ambrosio, executed a federal search warrant at ARCOMM Inc. 82 Broad Street, Weymouth, Massachusetts. Assisting with the execution of the warrant were, S/A Wayne Miller, S/A William Murphy, Boston Police Detective Paul Barnicle and Boston Police Officer Michael Ahearn.

At approximately 8:00am SA D'Ambrosio spoke telephonically with Richard Brown, co-owner of ARCOMM Inc. Brown was advised of the search warrant and asked to come to the business to open the door and disable the alarm system. Brown refused to assist and provided the alarm code (8754). At 8:10am forcible entry was made to the premises. Photographs of the interior were taken prior to the start of the search. A search of the business which consists of an office space, bathroom and workshop resulted in the seizure of the following items:

1. Three (3) pieces of wire each approximately four (4) inches long.
2. One (1) roll of silver duct tape.
3. One (1) Bowman, electrical catalog.
4. One (1) vacuum cleaner bag from a Dirt Devil vacuum cleaner.
5. One (1) ARCOMM customer list of electronics companies and customers.
6. Two (2) Radio Shack receipts dated, 10-2-91 and 10-24-91.
7. One (1) BJ's Wholesale receipt dated 10-22-91.
8. One (1) Advanced Research Communications cash receipts listing.
9. One (1) white wire, containing four multi-colored wires.
10. One (1) J&L industrial supply catalog.

DETAILS (Continued)

During the course of the search, SA D'Ambrosio received a telephone call at approximately 11:35am from Attorney Cosgrove who stated that he represented Alfred Trenkler, a co-owner of ARCOMM Inc. Attorney Cosgrove asked if SA D'Ambrosio held an arrest warrant for his client. SA D'Ambrosio answered in the negative and the call was terminated.

Prior to departing the premises, SA D'Ambrosio replaced the front door lock, with a lock found in the workshop area, so that the front door would be secure upon departure. Photographs of the interior were also taken prior to departure.

A copy of the search warrant and inventory was left in the office and the door was secured at 1:31pm.
