REPORT OF INTERVIEW FEB 4 1992 @ 1050 HOURS.

WHEN I WAS LET IN THE CONFERENCE ROOM BY DENNIS LEAHY I HAD SAID SO THIS IS THE LIONS DEN. + LACOURSE

I HAD NEVER SAID I KNEW I HAD AN ATTORNEY BUT WANTED TO TALK ANYWAY. I TOLD THE ~~ATT~~ <sup>LEAHY + LACOURSE</sup> AGENTS THAT I ~~WANTED~~ MY MIT, CCS, <sup>RI</sup> CHRISTIAN SCIENCE, VIDEOCOM AND MOST IMPORTANTLY MY GEORGE DAMON FILES. ~~THE~~ <sup>LEAHY + LACOURSE</sup> AGENTS THEN TOLD ME THAT IT WAS GOING TO TAKE A WHILE LONGER TO COPY ALL THE RECORDS.

THEY DID NOT HAND ME MY COPY OF MY ADDRESS BOOK AS THEY INDICATE THEY DID. ~~ONE OF THE~~ <sup>LEAHY</sup> AGENTS TOLD ME HE THOUGHT I WAS "FULL OF SHIT" AND THAT I WAS LYING ABOUT MY INVOLVEMENT WITH TOM SHAY (JR). ~~HE~~ <sup>LEAHY</sup> SAID, "ARE YOU

AWARE THAT TOM SHAY (JR) HAS AIDS." I SAID, "NO BUT IT WOULD NO SURPRISE ME." ~~THE~~ <sup>LEAHY</sup> AGENT SAID, "WELL YOU KNOW YOU NOW HAVE AIDS, DON'T YOU? WE KNOW YOU HAD A PHYSICAL

RELATIONSHIP WITH HIM." I SAID, "THAT'S BULLSHIT, I NEVER TOUCHED THE AIDS." ~~THE~~ <sup>LEAHY</sup> AGENT SAID, "WELL WE KNOW YOU DID." I REPLIED, "WELL I KNOW I DID NOT" I WENT

ON TO SAY THAT I HAD A CLEAR MEMORY OF WHEN I MET JR

AND MY RELATIONSHIP

AND THAT IT WAS IN JUNE OF 1991 NEAR THE WHITE HEN PANTRY ON BOYLSTON STREET. ~~THE~~ <sup>LEAHY</sup> AGENT ASKED IF THAT WAS NEXT TO THE RAMROD BAR. I SAID YES BUT THAT I NEVER

WENT IN THERE. I WENT ON TO SAY THAT I WAS POSITIVE OF THE DATE BECAUSE MY ROOMMATE JOHN CATES WAS VACATIONING IN EUROPE AT THE TIME AND THE NIGHT I MET SHAY (JR) I HAD

BROUGHT JR TO JOHN CATES APARTMENT AND HE WATCHED TV WHILE I MUST HAVE FALLEN ASLEEP. I TOLD THEM <sup>LEAHY + LACOURSE</sup> (~~ATT~~ AGENTS) THAT A FEW HOURS LATER RICH BROWN CAME OVER ~~AND~~ TO JOHN CATES HOUSE

AND PICKED <sup>UP</sup> ~~A~~ MYSELF <sup>AND</sup> ~~A~~ TOM SHAY AND GAVE SHAY (JR) A RIDE TO A BLUE HOUSE WITH WHITE TRIM ACROSS THE STREET FROM A

SCHOOL AND IT WAS ON RICHMOND STREET IN DORCHESTER ALMOST  
LEAHY + LACOURSE  
AT DORCHESTER AVE. I TOLD THE ATF AGENTS THAT I ALSO HAD  
GIVEN JR A RIDE TO A FRIENDS STORE IN RHODE ISLAND WHERE  
JR MET A SHORT HEAVY GUY AND THAT I COULD NOT REMEMBER  
HIS NAME AND THAT I HAD LEFT SHAY JR THERE. <sup>LEAHY + LACOURSE</sup> THE AGENTS  
THEN ASKED IF I REMEMBERED THE ADDRESS AND I SAID NO  
THAT I WOULD HAVE TO DRIVE DOWN TO THAT AREA BECAUSE  
I HAD BEEN DIRECTED BY TOM JR TELLING ME TO TAKE  
RIGHTS AND LEFTS AND NEVER MENTIONED STREET NAMES.

THE AGENTS THEN ASKED ME IF I KNEW ABOUT SHAY (SR)'S  
LAWSUIT AND I SAID THAT I DID NOT KNOW OF THIS UNTIL I  
HAD READ ~~IN~~ ABOUT IT IN THE NEWSPAPERS AND ~~PUT TOGETHER~~  
~~AND TOGETHER~~ ASSUMED THAT BASED ON THE ARTICLE ABOUT  
SHAY JR AT THE MBTA PRESS CONFERENCE THAT THESE TWO  
EVENTS WERE SOMEHOW CONNECTED AND BASED ON THE VARIOUS  
ARTICLES THAT I WOULD PUT MONEY ON IT THAT SHAY JR OR  
SHAY SR DID THE BOMBING TO MAKE THE SETTLEMENT EASIER TO  
PUT THROUGH BECAUSE IT WOULD POINT TOWARD THE GAS STATION  
OWNERS THAT HE (SR) WAS TRYING TO SUE AND MAKE THESE  
GUYS (THE GAS STATION OWNERS) LOOK BAD. I THEN SAID WHAT  
ABOUT THE OWNERS OF THE GAS STATION - MAYBE THEY DID THE  
BOMBING TO DO A DEAL WITH ~~THE~~ SHAY (SR). <sup>LEAHY</sup> THE AGENTS THEN  
ASKED ME ABOUT RICH BROWN AND I TOLD THEM THAT I WAS  
HAVING BUSINESS PROBLEMS WITH RICH BROWN, MY PARTNER AT  
ARCOMM. I SAID THAT HE WAS HELPING MONEY FROM PAGER  
RENTALS AND NOT TURNING THE MONEY INTO METROMEDIA.

 LEAHY + LACOURSE  
~~THEM~~ THAT HE HAD BEEN LOOKING FOR ME IN REFERENCE TO  
 AN APARTMENT I AGREED TO RENOVATE AND THAT BRENT DONAHUE  
 A FORMER EMPLOYER  
~~NOT ONLY TOOK MATERIALS FROM~~ SCREWED ME OUT OF MONEY THAT  
 I WAS GOING TO PAY RENT WITH. WHEN I COULD NOT PAY RENT  
 I AGREED TO MOVE OUT OF THE APARTMENT IN HULL AFTER WHICH  
 BRENT CAME ~~TO~~ AND REMOVED THE REMAINING MATERIALS. THIS  
 FOR RENOVATION  
 WAS WHAT MICHAEL ~~NUESSEY~~ NUESSEY WAS WANTING ME TO PAY  
 BACK THE LANDLORD FOR. I ALSO HAD SAID THAT BRENT DONAHUE  
 HAD MADE THREATENING REMARKS TO ME WHILE I WAS AT HUGHAM  
 DISTRICT COURT MAKING AGREEMENTS TO PAY MICHAEL NUESSEY.

 PUBLIC KNOWLEDGE AND I HAD ADMITTED IT THEM.  
 LEAHY'S  
 THEIR STATEMENT THAT SAID, "I NOT GOING TO MAKE THE" IS  
 I SAID,  
 UNCLEAR TO ME. I SAID TO DENNIS LEAHY, "IF YOU'RE SAYING  
 TOM SHAM (JR) AND ~~ME~~ <sup>I</sup> MADE THE BOMB HOW WOULD YOU FIND  
 OUT IF NEITHER ONE SAID ANYTHING. DENNIS LEAHY THEN SAID  
 THAT I SHOULD READ SOME BOOK, THE TITLE ESCAPES ME,  
 ABOUT A MAN WHO COMMITTED MURDER AND TOLD NOBODY ABOUT  
 IT AND HOW HE WAS CONVICTED BECAUSE HE EVENTUALLY TOLD  
 ONE PERSON YEARS LATER. I TOLD DENNIS THAT THIS WAS  
 NOT THE CASE HERE AND THAT I WOULD BE WILLING TO WARE  
 A WIRE AND TALK TO TOM SHAM (JR) BECAUSE WHETHER OR  
 NOT HE HAD INVOLVEMENT, HE KNOWS I DO NOT HAVE ANY  
 INVOLVEMENT. DENNIS LEAHY THEN ASKED ME WHAT I WAS  
 DOING THE SATURDAY BEFORE THE BOMBING. I TOLD HIM,  
 BASED ON MY RECOLLECTION ~~WITHOUT~~ WITHOUT MY NOTES, THAT  
 I THOUGHT I WAS AT CHRISTIAN SCIENCE IN BOSTON DOING

 LEAHY + LACOURSE  
 A HELICOPTER LIFT OF EQUIPMENT. I TOLD THEM THAT ON SUNDAY I HAD THE DAY OFF AND HAD SPENT IT WITH JOHN CATES WHICH IS COMMON FOR EVERY SUNDAY. I ALSO SAID THAT ON MONDAY I BELIEVED I WAS BACK AT CHRISTIAN SCIENCE WORKING ON MICROWAVE DISHES. ~~DENNIS LEAHY AND AGENT LA COURSE BOTH GOT UP~~ AT THIS POINT I AGAIN ASKED FOR MY FILES AND DENNIS LEAHY AGAIN SAID THAT THERE WERE ~~ALSO~~ SO MANY FILES THAT IT WAS TAKING A LOT LONGER THAN THEY THOUGHT TO COPY THEM. I SAID THAT I WAS UNDER THE IMPRESSION FROM MARTIN COSGROVE THAT ALL THE FILES HAD BEEN COPIED. DENNIS SAID THAT THEY THOUGHT THAT THEY WOULD HAVE BEEN COPIED BY ~~THE~~ THE TIME I HAD ARRIVED BUT AGAIN IT WAS TAKING LONGER THAN THEY HAD EXPECTED. AGENT LA COURSE THEN GOT UP AND LEFT THE ROOM. I THEN ASKED DENNIS LEAHY IF HE COULD "FIX" THE TICKET I WAS GOING TO GET FOR OVERTIME PARKING AND HE SAID THAT HE COULD BUT THAT IT WOULD BE ILLEGAL. DENNIS LEAHY SAID THAT HE WAS GOING TO CHECK TO SEE IF MY FILES HAD BEEN COPIED. I SAID THAT I WAS GOING OUT IN THE HALLWAY TO HAVE A CIGARETTE AND LEAHY SAID OK. I FINISHED MY CIGARETTE AND RETURNED TO THE CONFERENCE ROOM. I SAT DOWN AND AGENT TOM D'AMBROSIO CAME IN AND SAT DOWN. D'AMBROSIO SAID TO ME THAT HE DID NOT BELIEVE ME AS TO ANYTHING I HAD SAID IN OTHER INTERVIEWS. I SAID THAT I HAD TOLD THE TRUTH. D'AMBROSIO SAID THAT HE THOUGHT THAT I WAS FULL OF SHIT. I SAID, "I DON'T HAVE TO TAKE THAT FROM YOU" HE SAID, "WELL WE THINK YOU ARE AND WE ~~TALK~~ KNOW THAT YOU ARE HOLDING

BACK." I SAID, "LISTEN, I ONLY GAVE THE KID (SHAY JR) 4 OR 5 RIDES IN JUNE OF 91 AND ~~THE~~ THE KID (SHAY JR) CALLED MY VOICE PAGER AFTER THAT BUT <sup>I</sup> NEVER CALLED HIM (SHAY (JR) BACK. I HAD SAID THAT MY ROOMMATE JOHN CATES HAD SEEN SHAY (JR) TWO OR THREE WEEKS AGO (PRIOR TO FEB 4-91) AT SOME BOOKSTORE ON BOYLSTON STREET NEAR JOHN'S BANK. I SAID THAT I REMEMBERED GIVING SHAY JR A RIDE TO SOME GUY'S HOUSE IN NAHANT AND THAT THIS GUY WANTED NOTHING TO DO WITH SHAY (JR) AND I COULD NOT REMEMBER THE GUY'S NAME OR ADDRESS. DAMBROSIO THEN ASKED ME ABOUT RICH BROWN. (AT THIS TIME I WAS VERY MAD AT RICH BROWN BECAUSE HE HAD SCREWED ME OUT OF MONEY AND I HAD BEEN SPENDING ~~AND~~ A LOT OF TIME TRYING TO PATCH THINGS UP WITH MY CLIENTS). I SAID THAT MY ~~FOR~~ SOON TO BE FORMER PARTNER RICH BROWN AND HIS GIRLFRIEND HAD A SERIOUS DAILY COCAIN PROBLEM AND BECAUSE OF HIS GIRLFRIEND, ARCOMM WAS ALL BUT OUT OF BUSINESS. DAMBROSIO THEN BROUGHT UP THE BIT ABOUT SHAY (JR) HAVING AIDS AND HOW DOES IT FEEL NOW THAT I HAVE AIDS. I SAID TO HIM THAT I DON'T HAVE AIDS AND THAT I NEVER HAD ANY KIND OF PHYSICAL RELATIONSHIP WITH SHAY (JR) NOR WAS I EVER INTERESTED IN ONE. DAMBROSIO THEN ASKED IF I HAD EVER TOLD JOHN CATES ABOUT THE 86 INCIDENT AND I TOLD DAMBROSIO THAT AFTER I HAD READ THE 91 INCIDENT ~~THAT~~ ABOUT THE 86 INCIDENT AND THAT THE DA THEN TOLD ME IF ANYTHING SIMILAR HAPPENED THAT I WOULD BE INVESTIGATED, I TOLD <sup>DAMBROSIO THAT I TOLD</sup> JOHN CATES ABOUT THIS POSSIBILITY. ~~AND THAT~~

DAMBROSIO SAID, "BACK TO TOM SHAY (JR), WE KNOW THAT YOU ARE MORE INVOLVED WITH THIS KID THAN YOU ARE TELLING US." I SAID, "LIKE I TOLD DENNIS (LEAHY) I MET THE KID (JR) IN JUNE OF 91 AND GAVE HIM A <sup>FEW</sup> ~~COUPLE OF~~ RIDES AND I CAN REMEMBER TAKING HIM TO A CLOTHING STORE IN RHODE ISLAND. THE FEW TIMES I HAD BEEN WITH THE KID CONVINCED ME THAT HE WAS A NIT WIT AND I DID NOT WANT ANYTHING TO DO WITH HIM. HE HAS ~~BEEN~~ ~~CALLING~~ CALLED MY PAGER A FEW TIMES BUT I NEVER RETURNED ANY OF THE CALLS. ~~YOU MUST BELIEVE~~ WHAT PISSES ME OFF IS THAT I KNOW I AM INNOCENT AND DENNIS LEAHY KEEPS ON SAYING TO ME THAT IF I HAVE NOTHING TO DO WITH THIS CASE I HAVE NOTHING TO WORRY ABOUT." DAMBROSIO THEN ASKED ABOUT THE SB DEVICE AND I SAID, "IT'S PUBLIC KNOWLEDGE THAT ~~THIS~~ THAT THING WAS NOTHING MORE THAN AN M-80 AND COULD NOT AND DID NOT HARM ANYONE OR ANYTHING, IT WAS A PRANK THAT WAS BLOWN OUT OF PROPORTION AND WHEN IT WAS REALIZED WHAT IT WAS THE CHARGES WERE DROPPED." I WOULD NEVER MAKE OR DO ANYTHING THAT HAD ANYTHING TO DO WITH DYNAMITE, I'VE NEVER SEEN IT IN MY LIFE." DAMBROSIO THEN SAID, "YOU'RE NOT TELLING ME EVERYTHING." I SAID, "I DON'T KNOW ANYTHING. ALL I KNOW IS I'M HERE TO PICK UP MY FILES AND YOU'RE DICKING ME AROUND. I WANT MY FILES NOW." DAMBROSIO THEN GOT UP AND <sup>LEFT THE ROOM</sup> ~~DENNIS LEAHY~~ ~~REAPPEARED~~ AND DENNIS LEAHY CAME BACK WITH JUST MY PHONE NUMBERS (ADDRESSES) <sup>BOOK</sup> I SAID TO DENNIS LEAHY, "WHERE'S THE REST OF IT, YOU TOLD ME YOU NEEDED MORE TIME TO COPY THE RECORDS AND ALL

I'M GETTING 15 MY PHONE NUMBERS THAT WOULD HAVE TAKEN  
10 MINUTES TO COPY, I THINK YOU GUYS ARE FULL OF SHIT."  
DENNIS SMILED AND SAID HE WOULD ~~THANK~~ ~~TO~~ SEE ME LATER  
AND I SAID I DID NOT THINK SO. I THEN LEFT ~~FOR~~ THE  
FEDERAL BUILDING.
