<p>This report pertains to an ongoing investigation into the October 28, 1991 bombing which occurred at 39 Eastbourne Street, Roslindale, Massachusetts, taking the life of a Boston Police Department Bomb Technician and critically wounding another.</p> <p>On February 6, 1992 Richard Brown and John Cates appeared before the Federal Grand Jury relative to this investigation. Grand Jury transcripts will be made available to those individuals listed on the Rule 6E letter as submitted by A.U.S.A Kelley.</p> <p>On February 7, 1992 at the United States Attorney's Office, Boston, Massachusetts, a meeting was held to discuss the aforementioned investigation. Present at the meeting were A.U.S.A Paul Kelley, ATF Supervisor Victor D. Palaza, ATF Special Agents Thomas D'Ambrosio, Sandra LaCourse, John Paolillo, Jeff Kerr and Boston Police Department Detectives Brendan Craven and Frank Armstrong.</p> <p>During the course of the meeting the following was discussed and agreed upon.</p> <p>A. Periodic surveillance on Alfred W. Trenkler will be maintained.</p> <p>B. Grand Jury Subpoenas will be obtained and served on Brian O'Leary, an occasional employee of AWT, a business previously owned by Trenkler; the Hull Cooperative Bank for records of Greenview Landscaping, a previous employer of Trenkler and Richard Brown, and Donna Shea, a longtime friend of Trenkler's and alleged co-conspirator of Trenkler's in a 1986 bombing</p>
