9. DETAILS:

On February 17, 1992 surveillance was conducted of Thomas Shay Sr.'s residence, 39 Eastbourne St., Roslindale, Massachusetts by Special Agents LaCourse, Paolillo and Cronin. The surveillance was initiated at 8:30 A.M. and ran continuously until 4:30 P.M. Four vehicles were observed at the Shay residence. The following three vehicles were parked in the driveway: a blue 1984 Oldsmobile, MA 196TGG, a blue Ford Mustang license unknown and a white panel bread truck license unknown. A 1986 Buick, MA 125LLO, was parked on Eastbourne St. in front of the residence. None of the vehicles moved while the surveillance was in progress. Shay was not observed at the residence during the surveillance.
