Jeanie Maguire stated the following:

Jeanie Maguire stated that her DOB is 2/24/63 and SSN is ██████████ Her telephone number is ██████████ and her husband's name is Kevin. She stated that both her and her husband work for the MBTA.

Jeanie Maguire stated that she didn't like her father (Shay Sr.) when she was growing up. She stated that he didn't treat her and her sister Amy as nice as he did his own children (Paula, Nancy and Thomas Jr.). She stated that Shay Sr. used to slap her and Amy around but had never abused any of his own children. She stated that she thought Shay Sr. didn't think of it as any kind of abuse, just as a form of discipline because his father had slapped him around for punishment when he was growing up. She stated that she gets along with him better now that she is grown up.

She stated that her Father and brother had a good relationship when Tommy was growing up. She described Tommy as being a "Mommy's boy". She stated that while she was growing up, she didn't witness any kind of abuse from either her father or mother towards Tommy. She stated that her mother and father both put a lot of time into helping Tommy out with his emotional problems.

DETAILS (Continued)

Jeanie Maguire stated that she hated Tommy because of the way how he was. She stated that Tommy had stolen things from her and because of that reason, didn't want him in her home. She stated that Tommy had stolen a huge piggy bank from her. She described Tommy as being very immature. She stated that he had a wide imagination and liked to seek attention. She stated that Tommy was a loner and didn't have any friends. She further stated that she could always tell when Tommy was lying because he would smile. She stated that when Tommy was telling the truth he would have a serious look on his face.

She stated that Tommy always had emotional problems and that he used to like to light fires. When asked why she thought Tommy had emotional problems during his childhood, she stated that Tommy was in and out of schools during most of his childhood and that she knew of an incident that occurred at the Nazareth School when Tommy was about eleven. She stated that at that age, Tommy had told his psychiatrist and mother that he was sexually molested by one of the counselors. She stated that she thought maybe this incident may have been the cause of Tommy's emotional problems.

Jeanie Maguire stated that her father first learned of Tommy's sexual preference when he was watching People Are Talking. She stated that her father wasn't upset by the fact that Tommy was gay but was upset by the way how he found out.

She stated that she knew Tommy had given a deposition for her father. She further stated that, to the best of her recollection, Tommy didn't talk much about the deposition. However, she stated that she heard that her father's chances of winning the lawsuit weren't very good after Tommy had given his deposition.

She stated that Tommy got along good with his father but not with Mary Flanagan. She stated that Mary didn't want Tommy living with her and Shay Sr. because Tommy had stolen things from her. She stated that Tommy had stolen Mary's mother's jewelry.

She stated that the last time she heard from Tommy was when he had just been released from prison. She stated that Tommy most likely wouldn't call her if he was in trouble because he knew she didn't like him.

She stated that she had asked Tommy if he had called in a bomb threat to the MBTA station soon after the bombing. She stated that he denied calling in the bomb threat.

She stated that Tommy wasn't a violent person and wasn't capable of an act of violence. She stated she talked to her father regarding bombing and that her father denied that he had said that he thought Tommy was involved.
