"LAB TRANSMITTAL"

This report pertains to the investigation of the bombing that occurred at the residence of Thomas Shay Sr., 39 Eastbourne Street, Roslindale, Ma. in which a Boston Police Bomb Technician was killed and another critically injured. ATF, in conjunction with the Boston Police Homicide Unit, is currently investigating this matter.

Investigation has disclosed that Thomas Shay Jr. is one of the suspects. Further investigation disclosed that Shay Jr. wrote a 2-page letter to his mother. Investigation has recovered page 2 of the letter. It is requested that an Identification Examination be conducted on page 2 of the letter to determine if page 1 of the letter can be raised.
