"LAB TRANSMITTAL"

This report pertains to the investigation of the bombing that occurred at the residence of Thomas Shay Sr., 39 Eastbourne Street, Roslindale, Ma. in which a Boston Police Bomb Technician was killed and another critically injured. ATF, in conjunction with the Boston Police Homicide Unit, is currently investigating this matter.

Enclosed are samples of items purchased from the Radio Shack Store, 197 Mass. Ave. Boston, Ma. These items were purchased on 10/18/91 under the name SAHY, JYT (A copy of the sales slip is enclosed). It is the opinion of investigating agents that these items may have been used in the construction of the bomb. It is requested that these items be used to determine if any of the debris recovered at the scene of the explosion could have come from any similar type items.
