REPORT OF INTERVIEW

With Mr. Edward Carrion
 on February 27, 1992 at 5:15 p.m.
 by Special Agents Dennis P. Leahy
 and Victor D. Palaza, Bureau of
 Alcohol, Tobacco and Firearms
 Boston, Massachusetts
 Made on February 28, 1992

Mr. Carrion was picked up by Special Agents Palaza and Leahy at his place of employment. The Harvard Community Health Plan, Brookline Ave., Boston, MA. Mr. Carrion had previously agreed to take Special Agent Leahy to the residence in Milton where he had previously driven and dropped off Thomas A. Shay (Jr.).

Mr. Carrion directed the agents to drive to Milton via the Southeast Expressway. He then directed us to the vicinity of Whitelawn Ave. and Canton St. He then directed us to drive the length of Whitelawn Ave..

He stated that he remembered the house as being an older home and not one of the newer homes on the street. We stopped our vehicle at one end of the street where there were several older homes. We exited the vehicle and Mr. Carrion walked up and down that portion of the street, looking at the homes. He stopped in front of #7 Whitelawn Ave., across the street from a newly remodeled home, and

said that he was 99% sure that the house was #7. Carrion said that sometimes he would leave Shay (Jr.) off at the end of the street and observe him walk toward the house. Carrion said that he first took Shay Jr. to Whitelawn Ave. around the end of 1988 or the beginning of 1989. He said that the last time he took Shay Jr. there was May 1990. Carrion said that on these occasions, Shay Jr. told him he was going to visit his lover, who was an older man who lived in Milton. Carrion described this man as being in his early 30's, with a mustache, bulky build, not very tall.

Carrion said that he also took Shay Jr. to another house, which he thought was his mother's (Shay Jr.) house. He said that this house was on the Milton-Mattapan line, just beyond Mattapan Square.

Carrion said that he has not heard from Shay Jr. since mid to late October 1991. He said the last time he saw Shay Jr. was when he, (Shay Jr.) came to Carrion's apartment on Beacon St. at about 11:30 p.m. Carrion said that Shay Jr., was drunk and was banging on the door, claiming to be the police.

Carrion said that the last time he saw Shay Jr., with the individual he (Carrion) had previously identified from a photograph as "Al", was at the end of 1989 and the beginning of 1990. He said he saw them together approximately five or six times, maybe more or maybe less, in the area known as "the block". Carrion described "the block" as the area around the Greyhound Bus Terminal. Carrion said that he never gave "Al" a ride home because "Al" usually had a car. Carrion recalled that Shay Jr. had a strong hatred for his father which was probably caused by a sense of abandonment and physical abuse.

Carrion said that Shay Jr. liked to have sex with young boys around 15 or 16 years old, that he (Shay Jr.) would have sex in return for money with older men. He would then use this money to pay young boys to have sex with him. Carrion said that Shay Jr. liked oral sex and described him as being "passive/receptive". He said that Shay Jr. often talked about having sex with older men and referred to them as his "sugar daddies." Carrion also said that these older men were known as "Ice Cream Men"; and he named Dennis, two Larry's, and a Carl as being "Ice Cream Men", that being older men who liked to have sex with young boys. He said that Carl works for the Fleet Bank.

Carrion said that Shay Jr. began to talk weird from 1990 on. He said that Shay Jr. always carried a knife, on occasion wore camouflaged fatigues, dabbled in electronics, and pretended to be a para-medical.

Carrion said that during the summer of 1991 Shay Jr. talked about the fact that his father was going to die and that he (Shay Jr.) was going to come into a lot of money. Carrion said that Shay Jr. would often change his story and alter the facts.

Carrion said that he would be willing to make some inquiries and reach out to Shay Jr. He also said that he felt Shay Jr. would try to get in touch with him, since he (Shay Jr.) usually did so when he was in trouble. Carrion said that he would be willing to tape record any telephone conversations he might have with Shay Jr.

Prior to returning to his residence, Carrion showed us the "block area"; we drove around the "block" several times and Carrion attempted to identify any "ice cream men" that may have know Shay Jr. Carrion did not recognize any one in the "block area".

We returned Carrion to his apartment at approximately 7:45 p.m.
