REPORT OF INTERVIEW

With Allan C. Kingsbury, former Radio Shack employee, on March 3, 1992, at Choice Mart, 181 Massachusetts Avenue, Boston, Massachusetts, at 7:15 p.m., by Special Agents Jeffrey S. Kerr and Sandra R. LaCourse, Bureau of Alcohol, Tobacco and Firearms.

Allan Kingsbury stated the following:

Allan Kingsbury stated that his DOB is 04/29/71. He refused to give his SSN. Mr. Kingsbury stated that he had been employed by Radio Shack at 197 Mass Ave., Boston for seven months and was just recently hired by Choice Mart in early February. He stated that he could be reached at Choice Mart during the hours of 3:00 P.M. - 12:00 Midnight. He stated that the phone number at Choice Mart was 262-8588.

When Allan Kingsbury was shown a Radio Shack receipt dated 10/18/91 and bearing the name of SAHY JYT and address of 5100, he laughed and smiled. When asked why he reacted in such a manner, he stated that he remembered the sale because the customer gave Dwayne, the salesman, a hard time about giving his address. Upon his review of the items listed on the receipt, he stated that he remembered finding the boxes for the customer because Dwayne didn't know where they were. When asked if he could remember anything else about the sale, he stated that he remembered that the customer was hesitant about receiving his sales receipt. He stated that the customer looked as if he wasn't sure if he wanted his receipt. He stated that to the best of his recollection, the customer did take his

receipt. He stated that during the sales transaction, he was standing to Dwayne's left.

When asked to recollect the description of the customer, Allan Kingsbury stated that he thought the guy was shorter than Dwayne (who is approximately 6'2"). He stated that he thought the customer was of medium height, and surmised that he was around 27 years of age. He stated that he thought he was white guy with dark complexion. He stated that he thought he may have been a Middle Eastern man.

When shown a photo array including a photo of Thomas A. Shay (which was photo # 4), Mr. Kingsbury identified photos # 3 and # 4 as being individuals he believes may have been customers in the store at some time. He stated that he couldn't associate either photo, however, with the sale on October 18, 1991.

When shown a photo array including a photo of Alfred Trenkler, Mr. Kingsbury identified the photo of Alfred Trenkler as being a customer he had seen in the store on several occasions.

On March 4, 1992, Allan Kingsbury informed S/A LaCourse that he recalled that the customer who made the purchase on October 18, 1991, was with someone at the time of the sale. He stated that he remembered that when Dwayne had asked the customer for his address, the customer had turned around to the man standing behind him and had asked "5100 what?". He recalled that the other man may have said a popular street such as Huntington Ave.

On March 10, 1992, S/A LaCourse showed Allan Kingsbury a photo array including a photo of Rich Brown. Mr. Kingsbury was unable to identify any of the photos.

On March 11, 1992, S/A LaCourse showed Allan Kingsbury radio shack receipts, dated 10/18/91, which were of sales approximately one hour before and one hour after the sale to SAHY JYT, which was at 2:36 p.m. Mr. Kingsbury remembered one of the receipts which was the sale of a watch to a customer at 2:38 p.m.
