

TOM SHAY MARCH 24 INTERVIEW AT 0400 HOURS

- ① SHAY STATES THAT HE MET ME 2 YEARS AGO
- ② STATES THAT HE SLEPT WITH ME ONCE
- ③ STATES HE HAD BEEN TO MY HOUSE ONCE IN QUINCY
- ④ WENT TO A PARTY WITH ME ONCE
- ⑤ STATES HE HAD BEEN TO MY WORK SITE ONCE IN CAMBRIDGE

① I HAVE KNOWN TOM SHAY (JR) AS OF MARCH 1992 10 MONTHS. I HAD GIVEN (JR) 4 RIDES IN JUNE OF 1991 AND ONE RIDE IN AUGUST OF 1991 WITH JOHN CATES. THE REASON I AM POSITIVE OF THIS IS THE FACT THAT JOHN CATES WAS VACATIONING IN EUROPE DURING JUNE OF 1991 (SEE JOHN CATES PASSPORT) AND I WAS STAYING AT HIS HOUSE AT 133 ATLANTIC STREET IN QUINCY. BEFORE THIS, FROM OCTOBER OF 1990 UNTIL DECEMBER OF 1990 I LIVED AT JOHN CATES 133 ATLANTIC ST APARTMENT. I STAYED AT ~~AN APARTMENT~~ PATEL 144 OLD COLONY AVE FOR ONE WEEK WHILE JOHN CATES VACATIONED WITH FRIENDS IN JAMAICA (SEE JOHN CATES PASSPORT). THEN FROM DECEMBER OF 1990 UNTIL DECEMBER 15 1992, WITH THE EXCEPTION OF JULY 1991 WHEN I WORKED ON A JOB FOR MARCUS COMMUNICATIONS AND STAYED IN CONNECTICUT FOR THE DURATION OF THE JOB (14 DAYS) WITH <sup>328 3772</sup> RICH BROWN, <sup>QUINCY</sup> BILL MILLER, DAVE GAWS AND HIS BROTHER, I LIVED AT JOHN CATES 133 ATLANTIC STREET APARTMENT SPENDING EVERY NIGHT WITH JOHN CATES, WITH THE EXCEPTION OF JUNE 1991 WHEN JOHN CATES VACATIONED IN EUROPE (SEE JOHN CATES PASSPORT) AND EVEN THEN <sup>LANDLORD</sup> MIKE GREEN KNEW I WAS STAYING DURING JOHN'S VACATION. DURING THE TIME LIVING WITH JOHN CATES I HAD GIVEN HIM RIDES TO AND FROM WORK.

REASONS I KNOW WHEN I MET TOM SHAM JR

- ANOTHER REASON I KNOW OF THIS IS BECAUSE PRIOR TO SEPTEMBER OF 1990 I DID NOT OWN A CAR AND THE FIRST TIME I GAVE (JR) A RIDE WAS IN MY 78 TOYOTA.
  - ANOTHER REASON I KNOW OF THIS IS BECAUSE WHEN I MET (JR) IT WAS IN THE SUMMER TIME SINCE I DO NOT GO TO THE FEN'S WHEN IT IS COLD OUT.
  - ANOTHER REASON I KNOW OF THIS IS BECAUSE THE FIRST MORNING I MET (JR) RICH BROWN HAD GIVEN (JR) A RIDE TO RICHMOND STREET IN DORCHESTER AND THEN RICH BROWN AND I WENT TO A MEETING CONCERNING CHRISTIAN SCIENCE.
  - ANOTHER REASON I KNOW OF THIS IS BECAUSE THE MORNING I MET TOM SHAM, I POINTED TO THE CHRISTIAN SCIENCE BUILDING, WHICH IS VISIBLE FROM THE FENWAY VICTORY GARDEN ENTRANCE, AND SAID THAT I WILL BE WORKING ON THAT BUILDING WITHIN THE NEXT FEW MONTHS, + ONLY KNEW OF THIS SINCE SEP 90
  - ANOTHER REASON I KNOW OF THIS IS BECAUSE THE PHONE # OF MY VOICE MAIL SERVICE (553 0778) HAD BEEN ISSUED TO ME ONLY A FEW MONTHS PRIOR TO JUNE OF 1991 (CHECK WITH MARTIN ALEXANDER OF METROMEDIA 562 3236).
  - ANOTHER REASON I KNOW OF THIS IS BECAUSE AFTER OCTOBER OF 1990 WITH THE EXCEPTION OF JUNE OF 91, THE ONLY TIMES I WENT OUT - ANYWHERE - WAS WITH JOHN CATES.
  - ANOTHER REASON I KNOW THIS IS WHEN I WAS WITH JOHN CATES IN AUGUST AND WE BOTH SAW JR I COMMENTED THAT I HAD JUST RECENTLY MET JR AND WAS CONVINCED HE WAS CRAZY

- (2) I HAVE NEVER "SLEPT" WITH TOM SHAM (JR). THE FIRST TIME I MET (JR) BEING PHYSICAL WAS NOT A PART OF OUR MEETING - (JR) JUST WANTED A RIDE HOME. DURING SUBSEQUENT MEETINGS WITH (JR) I REALIZED THAT HE WAS IN DESPERATE NEED OF A FRIEND, A FRIENDSHIP I COULD NOT OR WOULD NOT PROVIDE, NOT THAT I WAS MEAN TO (JR), I JUST MADE IT CLEAR TO HIM THAT I THOUGHT HE HAD NO FRIENDS BECAUSE HE WAS AN ADROIT LIAR.
- (3) TOM SHAM (JR) HAD BEEN TO MY HOUSE ONCE, JOHN CATES 133 ATLANTIC STREET HOUSE, AND THAT WAS THE MORNING THAT I HAD FIRST MET (JR) IN JUNE OF 1991.
- (4) I NEVER WENT TO ANY PARTY WITH TOM SHAM (JR). THE FOURTH TIME I HAD SEEN (JR) HE HAD LIED TO ME TO GET ~~FROM~~ ME TO DRIVE (JR) TO A FRIENDS HOUSE IN NAHANT AND TOLD ME THAT THERE WAS A PARTY GOING ON AND THAT WE WERE INVITED. WHEN WE ARRIVED THERE WAS NO PARTY AND THE GUY THAT LIVED IN NAHANT WANTED NOTHING TO DO WITH (JR) OR MYSELF SO I TOOK TOM SHAM BACK TO HIS MOTHER'S HOUSE IN QUINCY. ON OCTOBER 23 1991 TOM SHAM (JR) CALLED MY VOICE MAIL SERVICE AND ASKED IF I WOULD LIKE TO COME TO A HALLOWEEN PARTY AT A FRIENDS HOUSE. JOHN CATES ALSO LISTENED TO THE MESSAGE BUT WE DECIDED NOT TO CALL <sup>SHAM</sup> ~~IT~~ BACK.

- (5) TOM SHAY (JR) DID GO WITH ME TO A WORK SITE AT VIDEOCOM IN DEDHAM - NOT CAMBRIDGE. DURING THE COURSE OF MY WORKDAY I HAD STOPPED AT MACDONALD'S ON BOYLSTON STREET ACROSS FROM FENWAY PARK (SEE PAGE (3) OF (4) IN TOM SHAY REPORT) AND HE ACCOMPANIED ME TO VIDEOCOM IN DEDHAM AND SAT IN THE CAR WHILE I CLIMBED A MICROWAVE TOWER TO TAKE MEASUREMENTS. THEN TOOK HIM TO A FRIENDS PLACE OF BUSINESS IN ATTLEBORO MA (RANDY STOLLER'S BUSINESS). I NEVER TOOK SHAY ANYWHERE IN CAMBRIDGE BECAUSE I DID NOT HAVE ANY JOBS IN CAMBRIDGE UNTIL DECEMBER OF 1991.
