9. DETAILS:

This report pertains to the investigation on the bombing that occurred at the residence of Thomas Shay Sr., 39 Eastbourne St., Roslindale, MA. in which a Boston Police Bomb Squad member was killed and another critically injured. ATF, in conjunction with the Boston Police Homicide Unit, is currently investigating this matter.

On March 5, 1992, a microcassette recording containing a discussion with a key suspect of this investigation was received as evidence.

On March 6, 1992, Special Agent Sandra LaCourse telephonically spoke with Jack Hunter of the Tactical Operations Branch regarding the audio enhancement of the tape. As requested by Mr. Hunter, transmitted herewith is the original microcassette recording for the audio enhancement procedures reducing the amount of background noise contained in the tape and enhancing the discussion of the key suspect.
