9. DETAILS:

This report will serve to transmit supplemental information relative to the report of interview with Jeanie Marie Maguire on February 25, 1992 which was inadvertently omitted from the original report.

Jeanie Maguire stated that on the day of the bombing, she answered a message on her answering machine when she came home from work at approximately 5:45 p.m. She stated that her girlfriend, who works at the Roslindale Post Office with Mary Flanagan, had left a message to call her when she got home. Mrs. Maguire stated that when she called her girlfriend, she was then informed of the bombing that occurred at her father's home. She stated that she then immediately called her family at 200 "The Falls" to inform them of the explosion. She stated that after she hung up the phone, she drove to 200 "The Falls" to see her family. She stated that when she got there, her mother wasn't there because she hadn't arrived home from work yet. She further stated that Tommy Jr. was surprised by the news.
