This report pertains to ATF's investigation into the October 28, 1991 bombing which occurred in Roslindale, Massachusetts taking the life of Boston Police Department Bomb Technician Jeremiah Hurley and critically wounding Bomb Technician Francis Foley.

On March 12, 1992 Special Agents Thomas D'Ambrosio and Jeff S. Kerr interviewed Robert Richardson, DOB: 05/22/70, S.S #

Richardson stated that he met Thomas A. Shay January 1, 1990. He stated that he met Shay at a New Years party and that a police officer had walked by the two men and Shay had said "Pig" and then said to Richardson that he (Shay) should of hit the police officer over the head.

Richardson stated that he saw Shay on a number of occasions at BAGLY (Boston Alliance of Gay and Lesbian Youths) meetings. He stated that these meetings are held every Wednesday night often at St. John's Episcopal Church. He stated that the BAGLY group leader is an individual named Sterling Stowell, Tel. No. [REDACTED]

Richardson stated that he tries to stay away from Shay. He stated that Shay was not his type of friend. He stated the last time that he saw Shay he (Shay) was apologetic to everybody for whatever he had done. He stated that after BAGLY meetings Shay hung around with a minor, Angelo LNU.

Richardson stated that he on one occasion had a sexual encounter with Thomas A. Shay. He stated that he was never physical with Alfred Trenkler but that he had met him at a couple of Donna Shea's parties.
