shay put His Hands over the telephone so I could not answer it, so finally I SNATCH the Telephone AWAY from mr Thomas shay, and I answered it, and it was the AT&T operator. She said WAS this the Medical Unit and

Mr Shay said he will get me back and he also said that he will get me kicked out of the medical unit.

Approx. 7:20 PM Lt Larkins and Mr Thomas Shay approach me and Mr Shay stated in front of Lt Larkins that I Mark Means made the bomb threat. I told Lt Larkins that I did not ~~know~~ make any bomb threat at all. I told Lt Larkins that Thomas Shay had an argument with me and that he was going to get me back some how. So Lt Larkins moved Mr Shay to the psych side of the medical unit.
