<p>REPORT OF INTERVIEW</p> <p>With Peter Cataldo, 225 W. Plain Road, Wayland, Massachusetts, on April 15, 1992, at approximately 1:00 p.m., at the above address by Detective Brendan Craven, Boston Police Homicide Unit, and Special Agent Sandra R. LaCourse, Bureau of Alcohol, Tobacco and Firearms.</p> <p>Peter Cataldo stated the following:</p> <p>Peter Cataldo was first greeted by Detective Craven. Det. Craven stated that after his introduction, he asked Mr. Cataldo if he (Cataldo) knew either Al Trenkler or Rich Brown. Cataldo replied that he didn't know either one. At this time Agent LaCourse approached the door and stated that she liked the T shirt he was wearing. Cataldo then looked down at his shirt and saw he was wearing an Arcomm T shirt. He was asked who gave him the shirt and he replied "Al gave it to me". Cataldo stated that his friend, David Fardy, told him about the investigation and that he expected the police to be interviewing him.</p> <p>Cataldo stated that David Fardy introduced him to Al Trenkler. He stated that he worked on three different job sites for Trenkler. He stated he is a professional climber and gets hired by different companies to climb trees and towers. He stated that Trenkler never hired him directly. He stated that he was hired by the Design Shop to do the jobs for Al Trenkler and that he was paid by the Design Shop. He recalled that he helped Al with the helicopter lift at the Christian Science Building. Cataldo was</p>

asked if he could remember who else Trenkler had at that building to help with the work. He stated that one of the guys was about 5'11" and looked kind of stupid. He stated that he didn't know who he was. He stated that he also helped Al with a tower in Newton which he said was done last Fall. He stated that there was no excavation done. He said that they mounted a dish onto the tower. He stated that at that site, one of the kids helping was about 5'7", dark hair, young and rode a motorcycle. He said that Al's partner was also there and that he drove around in a Lincoln. He stated that the third site was in Dedham. He said at that site they added a section to the top of a tower. He stated that Al had also poured the concrete pads for the dishes next to the tower. Cataldo stated that he wasn't sure where in Dedham this site was but remembered that when he was up in the tower, he could see Royer Tree Service, Timber Tree Service and a gas station. Cataldo stated that he didn't socialize with Trenkler and that he hasn't heard from him since that last job he did for Al.

Cataldo stated that he was unaware of Trenkler's lifestyle. He stated that he was unaware of Trenkler's homosexuality and drug habits. He stated that Al never asked him or talked to him about explosives.

At the end of the interview, Det. Craven asked if Cataldo bought muscle magazines. Cataldo seemed annoyed by the question and inquired as to why he would want to know about that. Cataldo stated that he did buy muscle magazines but didn't state which ones in particular.

During the interview Cataldo was shown a photo array including a photo of Thomas A. Shay (photo #4). He stated that he thought photo #1 looked familiar but he didn't know why.
