REPORT OF INTERVIEW					
With Stephen G. Murray, on April 3, 1992, at approximately 7:45 AM., at Quincy, Massachusetts by Special Agent Jeff S. Kerr, Bureau of Alcohol, Tobacco and Firearms. Mr. Murray stated as follows:					
Mr. Murray stated that his date of birth is 8/3/53 and his social security number is 0-██-██. He stated that his mailing address is P.O. Box 99, Accord, Massachusetts, 02018. He stated that he does not have a telephone.					
Murray, when shown a photograph array which included a photograph of Thomas A. Shay, identified Shay after a second look at the array. He stated that Shay always had a baseball hat on when he (Murray) saw him and that it took him a little time to identify Shay without a hat on.					
Murray stated that the first time he met Shay was approximately two weeks before Halloween 1991. He stated that Shay stuck his head inside the store and asked if he (Murray) was Scott. He stated that when he answered no, Shay departed.					
Murray stated that the next time he saw Shay was either the 24th or the 25th of October at about 2:00 AM. He stated that Shay came in and asked him for a soda. He stated that he gave Shay a drink. He stated that Shay claimed to be an E.M.T. He stated that Shay talked a lot about Gary Starkey and his (Starkey's) drinking habit.					
Murray stated that the next time he saw Shay was early Sunday morning,

approximately 12:30 AM., 10/27/92. He stated that he went to his friend's (Scott Critcher) Halloween party. He stated that when he arrived at the party, Shay was cleaning the kitchen. He state that Shay told him that he (Shay) had consumed two bottles of liquor and two six-packs of beer. He stated that Shay left the party at approximately 1:45 - 2:00 AM., 10/27/92. He stated that to his knowledge Shay walked home.

Murray stated that he saw Shay a while later. He stated that he believed Shay had just been released from jail. He stated that Shay came into the store but that they did not engage in any conversation.
