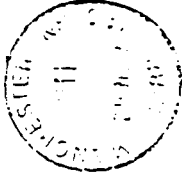
The sound thing its funny well I sure

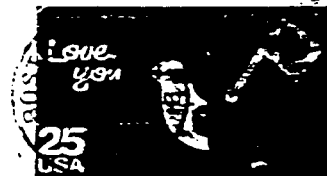
Dear anti Joyce and anti Dian please
