Sir:

On 10-31-91, P.O. Robert Foilb, I.D.#1093, Identification Section, fumed Mass. Reg. 125-LL0 using the cyanoacrylate fuming method (superglue). Between 10-31-91 and 11-1-91, P.O. Foilb lifted a total of 17 latent fingerprints.

On 11-14-91 P.O. Robert Silva, I.D.#7473 and Trooper Kenneth Martin, State Police, Identification Section processed Mass. Reg. 125-LL0 using the State Police Polilight. A total of 7 latent fingerprints were photographed.

A total of 24 latent fingerprints were developed from Mass. Reg. 125-LL0.

On 11-6-91 P.O. Foilb identified lift #4 as the #7,8 and 9 fingers of Michael Costello.

On 11-7-91 P.O. Foilb identified lift #3 as the left palm of Michael Costello.

On 11-7-91 P.O. Foilb identified lift #5 as the left hand of Michael Costello.

On 12/12/92 P.O. Foilb identified lift #1 as the right palm of Michael Costello.

On 1/28/92 P.O. Foilb identified lift #2 as the right palm of Michael Costello.

On 5/21/92 P.O. Foilb, P.O. Dennis LeBlanc and P.O. Robert Silva was assigned by Lieutenant Kelly to work exclusively on CC# 11-919-390.

Lift #13 identified as the left palm of Michael Costello on 5/23/92 by P.O. LeBlanc.

Lift #14 - insufficient ridge detail for positive identification.

Lift #15 identified as the right palm of Michael Costello on 5/24/92 by P.O. LeBlanc.

Lift #16 insufficient ridge detail for positive identification.

Lift #17 insufficient ridge detail for positive identification.

The 7 latent fingerprints developed by the polilight were photographed using a 35mm camera. The negatives were enlarged using the Crimcon camera. The latent fingerprint photographs were then compared to the list of names.

Negative #4 insufficient ridge detail for positive identification.


Negative #5 unidentified.
