9. DETAILS:

This report pertains to ATF's investigation into the October 28, 1992 bombing which occurred in Roslindale, Massachusetts taking the life of one Boston Police Officer and critically wounding another.

This report, as required by ATF O 3210.7B, Chapter Q page 127, 128, 129 and 130 will additionally serve as a request for the authority to utilize hypnosis as an investigative tool relative to the aforementioned investigation.

It is requested that Hypnosis Coordinator Louis Tomasello be activated in that capacity for the purpose of overseeing the hypnosis of one Thomas A. Shay, a subject of this investigation.

This request is made pursuant to Shay's continued request for the same. Shay has terminated his legal counsel, Attorney William McPhee. Attorney McPhee acknowledged the same on June 15, 1992 via telephonic conversation with A.U.S.A Paul Kelley.
