9. DETAILS:

This report pertains to ATF's joint investigation with the Boston Police Department into the October 28, 1991 bombing which occurred in Roslindale, Massachusetts taking the life of one Boston Police Department Bomb Technician and critically wounding another.

On July 16, 1992 one James Smith was interviewed by A.U.S.A. Paul Kelly, Boston Police Detective Brendan Craven and ATF Special Agent Jeff S. Kerr. The interview was conducted in the office of A.U.S.A. Kelly, 1107 POCH, Boston, Massachusetts.

Smith stated the following:

Smith stated that his date of birth is December 19, 1966 and his social security number is 013-58-4909. He stated that he currently resides at 100 Old Stone Way, Weymouth, Massachusetts. He stated that his prior address was 60 Bridle Path Circle, Randolph, Massachusetts.

Smith stated that he has no prior criminal record and that he is currently unemployed. He stated that he attended English High School in Boston and that he left school after the eleventh grade but received his high school diploma through the G.E.D. Program.

Smith stated that he first met Alfred Trenkler at a party which was being thrown by his (Trenkler's) roommate, Robert Craig. He stated that his (Smith's) friend Steven Wingert told him about the party. He stated that the party was held in Trenkler and Craig's apartment which was located in Quincy Center in a green apartment building. He stated that he could not be more specific as to the apartment's location. Smith stated that these

parties were held on a weekly basis for approximately one year. He stated that the same group of people would be present for each party. He stated that some of the people attending these parties were Richard Brown, Elaine Craig and Cliff "LNU".

Smith stated that he had not seen Alfred Trenkler in approximately two years. He stated that the last time that he spoke to Trenkler was at Trenkler's apartment in Hull, shortly after he (Smith) had been implicated in an attempted murder investigation. He stated that he was a passenger on a boat called "Wet Dreams" owned and operated by one John Shea. He stated that Shea after inviting two women out for a ride attempted to coerce the women into having sex. He stated that when the women refused Shea became enraged and threw the girls overboard. He stated that he was never charged and that he cooperated with the state investigators regarding the matter.

Smith stated that Alfred Trenkler was a frequent cocaine user. He stated that Richard Brown, ex-business partner of Trenkler's was a frequent cocaine user as was Trenkler's roommate, Robert Craig. He stated that he hadn't seen Brown since John Shea's trial for the "Wet Dreams" incident.

Smith stated that he was a heavy cocaine user in 1988. He stated that he hasn't used drugs in approximately eight to nine months. He stated that he bought his drugs from an individual named John "LNU", Heckler Street, Dorchester, Massachusetts. He described this individual as a tall male, black hair, brown eyes and a freckled face. He stated that he might bring some cocaine to a party to share with friends but that he did not consider himself a supplier. He stated contradictorily that on occasion he did sell cocaine to Trenkler. He stated that he either sold or used cocaine with Trenkler on approximately ten to fifteen times during the winter of 1988. He stated that Trenkler's drug habit was similar to his, approximately three times a week.

He stated that the quantities he sold to Trenkler were approximately one to two grams. He stated that these transactions were between the years 1988-1990. He stated that he resided with Trenkler and Craig for approximately two months during the winter of 1988. He stated that during that period he sold cocaine to Trenkler as well as supplied cocaine to Trenkler as a rent payment. He stated that he knew nothing about Trenkler's social life.

Smith stated that he is a heterosexual and that although he is not certain, he has heard rumors that Trenkler is gay. He stated that Robert Craig was not gay and that Craig's relationship with Trenkler was strictly that of roommates.

He stated that Trenkler worked on radio and cable towers to the best of his knowledge. He stated that Robert Craig and Richard Brown worked with

Trenkler. He stated that he (Smith) worked with Craig for approximately six months at a company called Work Inc.

Smith stated that he met Donna Shea, wife of John Shea, at Craig's and Trenkler's apartment. He stated that Donna Shea sells cocaine. He stated that he never discussed the Roslindale bombing incident with Donna Shea, John Shea, Richard Brown nor Alfred Trenkler.

Smith stated that he heard about a 1986 bombing incident which Trenkler was involved in. He stated that he heard about the incident from Robert Craig. He stated that Craig told him that Trenkler had hooked up a remote control device to a truck. He stated that Trenkler was very skilled in the electronics field.
