<p>This report pertains to ATF's joint investigation with the Boston Police Department into the October 28, 1991 bombing in Roslindale, Massachusetts which took the life of one B.P.D Bomb Technician and critically injured a second.</p> <p>On April 28, 1992 Special Agents Thomas D'Ambrosio and Jeff Kerr interviewed Randall Stoller, DOB: 07/21/56, S.S # 012-44-0316, 48 Lantern Lane, Sharon, Massachusetts. The interview was conducted at Stoller's place of business, Saltzmans Clothing Store, 40 Park Street, Attleboro, Massachusetts, Tel. No. (508) 222-0572.</p> <p>Stoller stated, that he first met Thomas A. Shay in May 1990 in the Blue Hills area in Milton, Massachusetts. He stated that Shay was driving a large green car with a revolving yellow light. He stated that Shay's automobile failed to start and that he assisted in trying to jump start the vehicle. He stated that the M.D.C Police eventually towed the vehicle.</p> <p>Stoller stated that on October 29, 1991, the day after the bomb detonated in Shay's father's driveway, Shay telephoned him and asked to be picked up in Quincy, Massachusetts. Stoller stated that Shay wanted to stay at his (Stoller's) residence. He stated that Shay made this request because his (Shay's) father's attorney had suggested that all family members relocate temporarily to avoid the danger of becoming a target of the bomber.</p> <p>Stoller stated that he did not want to bring Shay to his (Stoller's) residence and that he drove Shay to Providence, Rhode Island where he dropped Shay off at a familiar area frequented by gays.</p>

DETAILS (Continued)

Stoller stated that the next day, Shay again telephoned, this time requesting a ride to Dartmouth, Massachusetts. Stoller stated that he picked Shay up in Providence and drove him to a house located on the SMU campus located in Dartmouth.

Stoller stated that his friendship with Shay is like a father son relationship. He stated that he has taken Shay shopping and bought him on different occasions, basketball sneakers and a radio scanner. The scanner was purchased from Radio Shack in the Braintree Mall, Braintree, Massachusetts.

Stoller also stated that he had given Shay money on different occasions, including one hundred dollars for a physical.

Stoller stated that often Shay would call him for a ride and that he would drive to Quincy to pick him up. He stated that on one occasion Shay received a ride to his store (Saltzmans) from an individual he described as a white male, approximately 5'7", balding and dressed in work clothes. He stated that the man drove a beat up light colored car. The man stated that he climbed radio towers. Stoller believes that the man may of said that he owned his own business. Stoller stated that he got the impression from the meeting that Shay and this man had a physical relationship.

This investigation is continuing.
