<p>This report is being submitted as a supplement to a Report of Interview dated 12-4-91, (Report #23) prepared by Special Agent Dennis P. Leahy, relating to an interview of Richard Brown on November 20, 1991. The interview was conducted by Special Agent's Dennis P. Leahy and Thomas E. D'Ambrosio.</p> <p>A review of the above referenced Report of Interview and investigative notes indicates the following:</p> <p>Brown was re-interviewed telephonically the following day 11-21-92 by Special Agent Thomas E. D'Ambrosio. In that conversation Brown re-stated his discussion with Alfred Trenkler about the diagram that Trenkler drew. Brown again said that he couldn't believe that Trenkler drew a diagram of a bomb. Brown said that Trenkler told him that the agents left it behind and that he, Trenkler, had destroyed the diagram. Brown said that Trenkler didn't seem concerned about having drawn the diagram.</p> <p>Brown also said that the person he identified as Tom Shay, he thought, was the person he drove to a house in Dorchester from John Cates apartment. He did not remember where the house was located. He said that he now wasn't sure Shay was the person he gave a ride to, from ATEL in Boston to the "T".</p> <p>He also stated that Trenkler made a statement to him to the effect that the only way he would talk about confessing is with a written deal through an attorney.</p>
