9. DETAILS:

This report pertains to ATF's joint investigation with the Boston Police Department into the October 28, 1991 bombing in Roslindale, Massachusetts which took the life of one Boston Police Officer and critically wounded another.

A review of ATF F 3270.2 dated 12/08/92 and submitted by the undersigned disclosed errors in the report. This report will serve as a corrected version and an accurate account of the information documented in said report.

On November 20, 1992 the undersigned requested and received authority to utilize electronic surveillance relative to this investigation.

On December 2, 1992 the undersigned accompanied by Special Agent Thomas D'Ambrosio and Boston Police Detective Brendan Craven covered a UC meeting between CI# 97 and Alfred Trenkler. The meeting was conducted at the business of Trenkler's (ATNS), Weymouth, Massachusetts. Subsequent to the meeting CI# 97 and the aforementioned law enforcement officers listened to the recording and made specific requests and suggestions to the CI.

On December 9, 1992, Special Agent D'Ambrosio and the undersigned met CI# 97 to discuss the direction which the agents desired the CI to pursue.

On December 12, 1992 Special Agent D'Ambrosio and the undersigned determined that significant differences in CI # 97's method of operation conflicted with ATF's investigative philosophy and were not acceptable to the agents. It was determined that the differences between the CI and the agents were insurmountable and as a result authority for the CI to use
