**REPORT OF INTERVIEW**

With Kevin Troy Norris, on January 25, 1993, at 10:50 AM. at MCI-Walpole, Walpole, Massachusetts, by Special Agent Jeff S. Kerr, Bureau of Alcohol, Tobacco and Firearms. Present for the interview was Lt. Robert McGuiness, Investigations Unit for MCI-Walpole. Mr Norris stated the following:

Norris stated that his date of birth is March 25, 1973. He stated that he does not remember his social security number. He stated that his last residence was 501 Washington Street, Lynn, Massachusetts.

Norris stated that he is currently incarcerated on a conviction for rape. He stated he is serving a sentence of twenty-five to forty years.

Norris stated he was incarcerated at the Nashua Street Jail, Boston, Massachusetts following his November 5, 1991 arrest for the aforementioned rape charges. He stated that he was held in the 6-1 unit (Protective Unit). He stated that there were eight to ten inmates in the unit.

Norris stated that on a date which he cannot recall, an individual whom Norris later learned was Thomas A. Shay was brought up into the 6-1 unit in the middle of the night. He stated that to make room for Shay another inmate, George LNU was moved into another unit. Norris stated that he, Norris was in cell 2 and that Shay was placed in cell 4.

Norris stated his understanding of Shay's sudden move was that Shay and another inmate named Mark Means had an altercation of some sort. He stated that the altercation followed a telephonic bomb threat called out

from the medical unit of the facility, where at the time, both Shay and Means were lodged.

Norris stated that Means was moved to the "hole" a holding area separate from the 6-1 unit but in close proximity. He stated Means continually asked people to mess with Shay

Norris stated that Shay asked him, Norris to protect him and offered a payment of twenty dollars every canteen day. He stated that this money would come from Shay's friend Bill LNU, (Bill McPhee). He stated that he met Bill. He stated Bill gave his phone number to him and said that he would put money in his canteen. He stated that he told Shay and Bill that he wanted the money up front. Then he told Bill to put one-thousand dollars in his, Norris' canteen or five-hundred dollars in the canteen and buy him a suit. He stated that Shay ended up giving him food every week. He stated that the food cost varied each week but ranged from ten to twenty dollars.

Norris stated that Shay followed him everywhere. He stated that Shay would follow him into the shower area and wait for him. He stated that Shay would sit and watch television with him. He stated that other inmates began to ask Shay if he did it.

Norris stated Shay told him he, Shay had placed the bomb under his fathers car, attaching it to the vehicle's gas tank. He stated Shay said when he placed and made the bomb he was very careful and wore gloves. Norris stated when he asked Shay why he would do this, Shay told him that it was because of what his, Shay's father had done to him and his sisters. Norris stated Shay claimed his, Shay's father had sexually abused and physically battered him and his sisters. Norris stated Shay told him that as a result of these abuses, he, Shay had spent a number of years in Psychiatric Homes.

Norris stated he asked Shay how he built the bomb. He stated Shay said he and another guy, whom he did not identify, purchased components of the bomb at a Radio Shack. Shay stated that the other individual helped pay for the components. Norris stated Shay never explained how to make a bomb despite his being asked this question. He stated that Shay said if people gave him lighters or if he had a microwave he could build a bomb and that because of this knowledge people should not mess with him.

Norris stated Shay said the officers had no case against him. Norris stated Shay bragged about being a cop killer. He said the cops investigating the case were stupid because they had believed his father was involved.

Norris stated he got sick of Shay and told him that he, Norris was going to let Means smack him. He state Shay got so scared that he requested

constant lock up. He stated Shay was mad at him and wrote letters claiming that he Norris wanted to beat him up.
