**REPORT OF INTERVIEW**

With William Miller, on February 16, 1993, at 11:00AM., at South Shore Plymouth, Washington Street, Braintree, Massachusetts, by Special Agent Thomas E. D'Ambrosio Bureau of Alcohol, Tobacco and Firearms, and Detective Brendan Craven, Boston Police Department.

Mr. Miller states as follows:

He said that he resides at 117 Water Street, Quincy, Massachusetts. He said that he is currently employed in the service department at South Shore Plymouth, Braintree, Massachusetts. Miller stated that in August of 1991, he worked for Alfred Trenkler as a laborer. He said that a mutual friend, David Gaines, of Worcester, Massachusetts, told him that Trenkler was looking for help on a job. He stated that the job site was in Vernon, Connecticut at a communication company. He did not remember the name of the company. He said that the job consisted of taking down an existing tower and replacing it with a new 150 foot tower. He said that he worked for Trenkler for five days on that job and stayed in the area at a Holiday Inn and a Colonial Inn. He said that Richard Brown and Phillip Gaines were also on that particular job. Miller further stated that he had planned on helping Trenkler with the pending job at MIT, which was discontinued due to Trenkler's arrest. Miller stated that on one occasion, Trenkler mentioned Thomas Shay, stating that he really didn't know Shay and had only seen him once or twice.
