REPORT OF INTERVIEW

With Paul Nutting, on April 7, 1993, at 10000 hours, at ██████████
 ██████████ by Group Supervisor Victor D. Palaza and
 Special Agent Dennis P. Leahy, Bureau of Alcohol, Tobacco and Firearms.
 Mr. Nutting states as follows:

Mr. Nutting said that he knew Al Trenkler and Tom Shay (the younger) and had seen them together in the Blue Hills area several times probably in the 1989/1990 time frame. Mr. Nutting said that the Blue Hills area was a known gay hangout for free sex. Mr. Nutting said that he thought that Al always drove, usually in a blue pickup truck and that sometimes they would separate in the Blue Hills and sometimes they would stay together. Mr. Nutting said that he remembered Tom Shay also being in the Provincetown area and that Shay would sometimes wear an "ACT UP" T-shirt.

Mr. Nutting said that he knew Al since the early 1980's and Shay since about 1989. Mr. Nutting said that he may have seen them also at several gay parties which were held in private homes. Mr. Nutting said that he lived in Milton, Massachusetts at the time. Mr. Nutting said that Tom Shay had a bad reputation and was widely known in the gay community.

9. DETAILS:

On 11/7/91 S/A Paolillo and S/A Anthony Thurman traveled to Urban Outfitters in Cambridge, Ma. to interview Abraxas Adams. Adams stated that he lived at ██████████ He works at Urban Outfitters in Cambridge, Ma. as a clerk. Adams was willing to give us any information that he could to assist in our investigation.

Adams stated that he did meet Tom Shay Jr. one time nearly three weeks ago. He does not recall the exact date, but it was one evening when Adams's roommate Dave Zimmerman brought Shay home from a nightclub to spend the night. Adams was introduced to Shay by Zimmerman that evening and the two had what Adams described as a "light conversation". Adams further stated that Shay acted very immature and appeared to be a little crazy. Shay spent the night over the apartment and the next morning Adams did not really speak to him. However, Adams observed Shay making sexual advances towards Zimmerman, but Zimmerman did not react positively to Shay's advances. Shay kept bragging and trying to impress other people in the apartment while he was there. Adams said that Shay did not make any comments relating to explosives in any way or making any bombs for personal pleasure. Adams further stated that Shay telephoned the apartment approximately one week later looking to speak to Zimmerman. Adams told Shay that Zimmerman wasn't home and Shay left a message that Zimmerman wanted a kitten that Shay had for sale. Adams knew nothing about a kitten and told shay that he would give Zimmerman the message.

Adams could not explain why his name and telephone number were in Tom Shay's book. Also, Adams never heard of anyone named Al Trenkler nor has he ever heard anyone mention his name in the past. Adams said that if he can be of any further assistance to please contact him.

Also on that date, S/A Paolillo and S/A Thurman traveled to [REDACTED] to interview Charles Hellyer. Hellyer is a dispatcher for Greyhound Bus Lines in Boston, Ma. Hellyer states that he does know who Shay is and that he has had conversations with him in the recent past. Hellyer first saw Shay hanging around the Greyhound Station two or three years ago and then he disappeared up until a month ago when he saw Shay again at the terminal. Hellyer states that Shay was just hanging around the terminal when he approached him. The two individuals had idle chat and got to know one another. Hellyer said Shay never mentioned explosives or bombs during any of their discussions. He said Shay kept the conversations very simple and without much interest. Hellyer further stated that the Shay and himself exchanged phone numbers but have not spoken since they last saw each other approximately a month ago.

Hellyer has never heard the name Trenkler before and also he never heard Shay mention the name Trenkler in the past. Hellyer has not seen Shay around the Greyhound Station since the bombing on 10/28/91. We advised Hellyer that if there is anything else he can recall to please contact our office as soon as possible.

Also on that date, S/A Paolillo and S/A Thurman traveled to Urban Outfitters in Boston, Ma. to interview Dave Zimmerman. Zimmerman is a clerk at Urban Outfitters and he does know Tom Shay from a previous experience. Zimmerman first met Shay at a nightclub called Boston Ramrod approximately a month ago. Zimmerman began speaking to Shay outside the club and eventually invited Shay back to his apartment for the evening. The two had a few drinks and talked for a little while. Zimmerman stated that Shay at no time during their conversations ever mentioned anything about explosives or electronics. Eventually the two fell asleep for the evening.

The next day, Zimmerman woke up and began to make everybody breakfast. Shay woke up and started asking Zimmerman for his phone number. Zimmerman did not want to give Shay his phone number but he feels Shay must of read the number off the phone in the apartment and copied it down without anyone knowing. After breakfast, everyone in the apartment went out for a walk and this included Shay. Zimmerman stated that as they were walking along Shay stopped to talk to an elderly gentleman who was coming out of a local laundromat. Zimmerman described the man as a white male, late 60's about 5'6'' and 145 lbs. Shay spoke with the gentleman for about ten minutes and then came back to the group. Zimmerman seems to believe that the gentleman that Shay was speaking to was either a cop or an ex-cop. TOM

Zimmerman has never heard of anyone by the name of Trenkler and he never heard Shay mention this name at all. Zimmerman has not heard from Shay since that evening but described him as being immature and self-centered.
