GOVERNMENT'S DEMAND FOR NOTICE  
OF ALIBI BY DEFENDANT

The United States of America hereby makes written demand, pursuant to Fed. R. Crim. P. 12.1(a), that the defendant serve written notice upon the government of any intention he may have to offer a defense of alibi.

This demand relates to one specific aspect of the offense. offense in Count One of the Indictment.

Overt Act (c)

It is alleged that on or about October 18, 1991 [at approximately 2:30 p.m.], defendant Shay purchased and acquired electrical components needed for the construction and testing of the explosive device [from the Radio Shack store at 197 Mass. Ave. in Boston]. Evidence will likely be offered at trial that defendant Trenkler was in the immediate vicinity of this store while defendant Shay was inside.


If defendant Trenkler intends to offer evidence at trial suggesting that he was not at or near the above-described location on the date and time indicated, the government hereby


requests notification of the same "within ten days."
