 THESE TWO MEN MAY BE RESPONSIBLE FOR THIS DEVICE, AND THAT THE  
 DAY BEFORE, HE FOUND THIS DEVICE AND THREW IT AGAINST THE HOUSE.  
 OPC POLY TESTIFIED THAT BECAUSE OF THESE STATEMENTS, HE AND GERRY  
 WERE OF THE OPINION THAT THIS IS NOT A BOMB AND TELL SIR NOT  
 TO WORRY. TRAGICLY, AND TO THIS DAY UNEXPLODED, THE DEVICE

 AN ARTICLE THAT ~~BOB DOB~~ ~~SECRET~~ OF TWO ~~BOMBING~~ CAPS, ~~IRAL CONNECTIONS~~  
 EMBEDDED IN THE WALL OF THE HOUSE NEXT DOOR  
~~TWO MEN IN A NEIGHBORING TOWN WITH IRA CONNECTIONS SOMEHOW CONNECTED~~  
 TO SR.

YOU HAVE HEARD THE TESTIMONY OF EXPERT WITNESSES EXPERT IN DETAIL  
 THE COMPONENTS IN THE 91 DEVICE, WHICH WERE DISCOVERED, YOU HEARD THEIR  
 TESTIMONY THAT THEY COULD NOT LINK ANY ITEMS TAKEN FROM MR  
 TRENKLER BOTH WITH CONSENT FROM MR TRENKLER THEN WITH SEARCH  
 WARRANTS EXECUTED BY THE ATF + BPD, YOU HAVE MONTHS LATER

YOU HAVE HEARD QUESTIONABLE TESTIMONY FROM TOM D AND DENNIS L ABOUT AN ALLEGED DRAWING OF THE 91 DEVICE TO INCLUDE TWO BISSING CAPS, MENTIONED IN THE OCT 29 1991 <sup>BOSTON</sup> ~~GLOBE~~ <sup>PROB 16</sup> NEWSPAPER, HOWEVER THIS DRAWING IS, EXAMINED BY ONE AGENT, LEFT AS AN OVERSIGHT, AND, BY ANOTHER AGENT, PURPOSELY LEFT SO AS TO NOT SHOW TRENKLER'S IMPORTANCE OF THIS ALLEGED DIAGRAM. NO REPORT IS MADE OF THIS EVENT UNTIL OVER TWO MONTHS LATER. NO SEARCH WARRANT IS SOUGHT UNTIL ALMOST 3 MONTHS LATER, ~~AND~~ AND WE ARE TO BELIEVE THAT THIS DRAWING WAS THE ONLY EVIDENCE LINKING MR TRENKLER TO THIS DEVICE - QUESTIONABLE AT THE VERY LEAST.

YOU HEARD TESTIMONY THAT SHAY JR WAS NOT A SUSPECT, WAS JUST THE SON OF THE VICTIM, UNTIL HE CALLED MULTIPLE PRESS CONFERENCE DRAWING THE ATTENTION TO HIMSELF. BY COINCIDENCE, SOMETIME IN AUGUST OF 1991, ALERED TRENKLER HANDS SHAY JR A BUSINESS CARD WITH HIS PAGER # ON IT BECAUSE JR ALLEGEDLY HAS AN IN WITH A LOCAL RADIO STATION. ALSO, BY COINCIDENCE, MR TRENKLER WAS INVOLVED IN A PRANK IN 1986 THAT MADE A LOUD NOISE AND A BRIGHT FLASH, THAT CAUSED NO DAMAGE, NO INJURIES, <sup>AND</sup> <sup>QPD</sup> SHI TESTIFIED THAT THERE WAS NO DAMAGE TO THE TRUCK, OFC LAMMERTON TEST. THAT HE DID NOT GO TO WHERE THIS EVENT OCCURRED, IN QUINCY, BECAUSE THE TRUCK WAS IN USE THE FOLLOWING DAY. TAKING THESE TWO SEPARATE COINCIDENCES, OFFICIALS HAD IT MADE. HERE IS THE SON = SHAY SR MAKING BOLD STATEMENTS THAT HE KNOWS IT ALL THAT DRAWS ATTENTION TO HIMSELF, COMBINED WITH THE FACT THAT MR T'S PAGER # APPEARS IN JR'S ADDRESS BOOK, FURTHER THAT MR T HAS BEEN INVOLVED IN A PRANK 5 YEARS EARLIER AND THAT MR T

IS AN ELECTRONICS ENGINEER, THE ATF + BPD HAVE IT MADE.  
SINCE NO OTHER LEADS SEEM TO PAN OUT ALL EFFORTS ARE FOCUSED  
ON SHAM JR + MR T.

THE GOVERNMENT HAS, WHAT IS CALLED IN LEGAL TERMS, STITCHED  
LITTLE BITS AND PIECES TOGETHER IN THE HOPES OF CONVICTING  
MR TREWELDER OF THIS HORRIBLE CRIME.

AS THE GOVERNMENT HAS STATED, THERE <sup>ARE</sup> NO EYEWITNESSES, THERE IS  
ONLY, AND I USE THE TERM LOOSELY, CIRCUMSTANTIAL EVIDENCE.

YOU HAVE HEARD FROM VARIOUS WITNESSES THAT JR KNEW OF  
HIS FATHER'S LAWSUITE AND THE APPROXIMATE DOLLAR VALUE. YOU HAVE  
ALSO HEARD THAT JR WAS OFFERED TO BECOME A PLAINTIFF IN THIS  
LAWSUITE BUT WAS NOT INTERESTED.

YOU HAVE HEARD FROM A RASH EMPLOYEE THAT SHAM JR PURCHASED  
PARTS ON OCT 18TH 1991, NONE OF WHICH EXCEPT A JOGGLE SWITCH  
WAS USED IN THE 91 DEVICE. ~~YOU HEARD LEAHY TESTIFY THAT~~  
THIS RASH EMPLOYEE EXPANDED THAT JR WAS IN THE STORE FOR  
FIVE MINUTES AT WHICH POINT HE ASKS JR IF HE NEEDS ANY HELP  
WHICH HE SAYS NO. 15 MINUTES PASS AND JR COMES TO THE COUNTER  
NO PROBLEMS WITH MR AMBRISTER FOR FOUR MINUTES. DURING THIS 4 MIN  
AMBRISTER TESTIFIED THAT THE ONLY INFORMATION JR GAVE HIM WAS  
THE # 5100. NO MENTION OF HOW SHAM JR WAS ENTERED OTHER THAN  
HE JUST ENTERED SHAM JR. NO MENTION OF WHERE 3780 CAME  
FROM, THE GOVERNMENT WOULD HAVE YOU BELIEVE THAT JR GAVE THIS  
#, COINCIDENTALLY THE SAME # AS SHAM SR'S # @ 39 LANSDOWNE ST  
WITH TWO #'S TRANSPOSED.

THE GOVERNMENT WANTS YOU TO BELIEVE THAT SINCE MR SHAY JR WAS NOT CAPABLE OF BUILDING THIS DESTRUCTIVE DEVICE, THAT HE TURNED TO MR TRENKLER TO MAKE IT FOR HIM, COINCIDENTALLY MR TRENKLER WAS WORKING ON A RATHER LARGE PROJECT FOR CHRISTIAN SCIENCE BETWEEN SEPTEMBER OF 91 AND MARCH OF 92 THAT JUST HAPPENED TO BE ACROSS THE STREET.

BUT THE COINCIDENCE THE GOVERNMENT DOES NOT WANT YOU TO LOOK AT IS THE FACTS BASED ON THE TESTIMONY OF EDWARD CARRION <sup>AN IN COMPUTER WITH ELECTRICAL KNOWLEDGE</sup> HE GOVERNMENT WANTS YOU TO BELIEVE THAT MR TRENKLER WAS KNOWN FOR UPWARDS OF 2 YEARS PRIOR TO OCT OF 91, THAT MR TRENKLER IS JR'S FINANCIAL SUPPORT, THAT TRENKLER SHOWED JR ELECTRONICS. ALL THIS THAT THE GOVERNMENT WANTS YOU TO BELIEVE ABOUT MR T HERE WITH MR CARRION. MR CARRION ADMITS KNOWING JR FOR 1/2 YEARS, HAS SEEN HIM IN EXCESS OF 40 TIMES DURING THIS PERIOD, GAVE HIM MONEY, FED HIM AND GAVE HIM RIDES. MR CARRION'S <sup>GEORGE NIGHTINGALE</sup> DONATE, COINCIDENTALLY THE MANAGER OF THE FAMOUS 197 MASS AVE TOW SHACK, HAD A REMOTE CONTROL ~~VEHICLE~~ CAR. MR CARRION TESTIFIED THAT JR HAD A PERSISTENT INTEREST IN ELECTRONICS, CIRCUITS AND <sup>EVERY</sup> ~~EVERY~~ REMOTE CONTROL. CARRION STATED THAT HE SHARED THIS KNOWLEDGE WITH JR, SINCE HE, CARRION, HAD A BACKGROUND IN ELECTRICALS. CARRION STATED THAT HE TOLD SHAY JR THAT THE PLACE TO GO FOR ELECTRONIC COMPONENTS WAS AUDIO SHACK. WHEN MR CARRION WAS ASKED AT THE MAGIC WORD 'SHUNT' HE IMMEDIATELY GAVE TWO CORRECT DEFINITIONS OF THE WORD - TO TURN A DEVICE ON OR OFF AND A ~~VEHICLE~~ <sup>VEHICLE</sup> OF ELECTRONICS. COINCIDENCE? ANOTHER COINCIDENCE, CARRION STATED THAT THE LAST TIME HE SAW SHAY JR WAS OCT 18TH 1991

THAT MR TRENKLER WAS IN WEYMOUTH AND, MAGICALLY AT THIS RADIO SHACK ON 197 MASS AVE AT 12 MINUTES PAST 2. OUR EVIDENCE SHOWS THAT MR TRENKLER SPENT THE DAY AT HIS 92 BROAD STREET OFFICE, MEETING WITH AN ACCOUNTANT UNTIL 2 PM AND REMAINING AT THE OFFICE PAINTING UNTIL THE END OF THE DAY AND GOING WITH A LABORER, NURDIN CAGDUS TOWARD THE END OF THE DAY TO CASH A CHECK.

YOU HEARD TESTIMONY FROM BRIAN O'LEARY THAT WHENEVER THERE WAS APPOINTMENT WORK, HE, BRIAN, WOULD BE CALLED IN TO COMPLETE WHATEVER APPOINTMENT WORK THERE WAS.

BACK TO THE EG DEVICE, YOU HEARD TESTIMONY FROM TODD LEACH AND BOB CRAIG THAT THE EXPLOSIVE DEVICE, THIS SIMULATOR, WAS SUPPLIED BY MR TRENKLER BUT BY DONNA SHEA. MR TRENKLER DID NOT SELECT A SIMULATOR, DID NOT "KNOW" SOMEONE IN THE MILITARY, DID NOT SAY "I NEEDED A SIMULATOR" TO DO THIS PRANK, THE SIMULATOR WAS MERELY "THERE" AND MR TRENKLER WAS COERCED INTO FINDING A WAY TO GET IT OFF - MOHAMMAD DID NOT GO TO THE MOUNTAIN, THE MOUNTAIN IS BROUGHT TO MOHAMMAD, THE POLICE DID NOT HAVE THE GOODS FROM MR TRENKLER, HE CONFESSED, HE ADMITTED THAT THIS WAS A PRANK AND THAT ITS PURPOSE WAS NOT TO HURT ANYONE OR ANYTHING, WHICH DID NOT, <sup>JUST</sup> ~~NOT~~ A PRANK. IN FACT THE CHARGE WAS POSSESSION OF WEAPONS AND THE CASE WAS DISMISSED. AS A RESULT, NO ONE ELSE WAS ARRESTED OR CHARGED AND, CONTRARY TO WHAT THE GOVERNMENT WOULD HAVE YOU BELIEVE, THERE WAS NO "DEAL" WITH THE COMMONWEALTH OTHER THAN NAMING DONNA SHEA AS THE INSTIGATOR. THERE IS NO EVIDENCE THAT SHAM JR AND TR WERE OBSERVED IN  
EACH OTHER'S COMPANY 30 DAYS PRIOR TO OCT 28TH, 60 DAYS PRIOR  
TO OCT 28TH, 90 DAYS PRIOR TO OCT 28. JOHN CATES TESTIFIED  
THAT JR TRIED TO REVENGE AL THRU HIS PAPER INVITING HE AND CATES  
A HALLOWEEN PARTY, TO WHICH AL DID NOT RESPOND AND INSTEAD HE (CATES  
AND AL) WENT TO A HALLOWEEN DINNER AT A DAVID MILLETTS HOUSE  
DORCHESTER BETWEEN 6 AND 2 AM ON THE 26TH OF OCTOBER.

YOU HAVE HEARD NOTHING THAT INDICATES ANY LONG TERM INTEREST  
IN REMOTE CONTROL VEHICLES OR TOYS, NOTHING THAT WOULD INDICATE  
AL T'S EXPERIENCE IN WOODWORKING, IN FACT BRIAN OLEARY TESTIFIED  
THAT HE BUILT THE BOXES FOR THE CSM JOB NOT TLEWIKER

YOU HAVE HEARD THE TESTIMONY FROM A DAVID LINDHOLM, A MAN WHO  
SOLD LARGE QUANTITIES OF MARIJUANA FOR ALMOST 20 YEARS - NOT REPORTING  
ANY INCOME DURING THIS TIME, CONVICTED OF TAX EVASION IN 1983, CONVICTED  
OF CONSPIRACY TO SELL MARIJUANA IN DEC OF 1990. THIS PERSON STATED HE  
LIVED ON AL'S STREET, WHICH HE DID NOT BASED ON TOWN RECORDS, REMEMBERED  
IT AND WITHIN 3 DAYS MR T ALLEGEDLY CONFESSES TO THIS CRIME.

INCIDENTALLY REPEATING STATEMENTS THAT SHAM HAD MADE TO OTHER INMATES AND  
WAS COINCIDENTALLY IN THE SAME CELL WITH TOM SHAM JR THE DAY BEFORE HE  
WAS WITH MR T. WE ARE TO BELIEVE THAT MR LINDHOLM, WHO FALSIFIED

TAX RETURNS TO FRAUDULENTLY OBTAIN 5 SEPARATE BANK LOANS IS NOW ON THE MEND AND IS NOW GOING TO REPORT THAT MR T CONFESSED TO MR L, NOT CONFESS TO HIS (MR'S) FRIENDS, OR CONFESS TO <sup>ANY OF 20 OF</sup> PEOPLE HE WAS HOUSED WITH FOR OVER 8 MONTHS. ANOTHER COINCIDENCE, LINDHOLM WAS SICK AND COULD NOT SLEEP, LARRY PUNT WAS ALSO SICK WHEN SAM JR CAME UP TO HIM AND BOMBED ABOUT BOMBING AND SAID JR SHOWED NO REMORSE "IT WAS THE OFFICER'S OWN FAULT" JUST LIKE LINDHOLM'S TEST. THE NEWSPAPER ARTICLES PUBLISHED BETWEEN THE 17<sup>TH</sup> AND THE 20<sup>TH</sup> JUST HAPPEN TO CONTAIN ALL THE INFORMATION THAT LINDHOLM RELAYS ~~AND IT IS HARD TO BELIEVE THAT THE ONE NEWSPAPER HE READS ONLY~~ ~~AND NOT ALL OF THE PAPERS AVAILABLE~~ ANOTHER COINCIDENCE?

T ON ~~THE~~ ONE OCCASION TELLS AN ATF AGENT THAT HE WOULD BE WILLING TO SPEAK TO JR ON BEHALF OF THE GOVERNMENT AND EVEN REPLY A WIRE TO WHICH THE AGENT DECLINED. BEFORE MR T LEAVES THE MEETING STATING "I'M NOT GOING TO MAKE THE ~~STATEMENT~~ DEAL YOU'RE TRYING TO MAKE WITH JR, I'M INNOCENT"

WE HAVE HEARD THE TESTIMONY OF MR SCHEID THAT OUT OF 14K BOMBINGS FROM 79 TO 91 THAT ONLY TWO DEVICES COMPARE, QUONIA AND 205LWUMRE. WE THEN HEARD THAT OF THE 5 GENERAL SIMILARITIES THERE WERE SOME 12 TO 16 DISSIMILARITIES. WE HEARD TESTIMONY FROM MR KLINE THAT HE HIMSELF HAS INVESTIGATED MANY REMOTE CONTROL DEVICES CONTAINING FOTABA / TOGGLE SW / MAG BATTIS / MAGNETS / SOLDERED WIRES / STRING COPS / WOOD / GLUE / DYNAMITE / DUCT TAPE / OFFICED UNDER VEHICLES THAT WOULD OBVIOUSLY BE MUCH CLOSER IN SIMILITUD TO 205LWUMRE THAN THE QUONIA DEVICE.

AS A MATTER OF FACT GUY HUMMER OF THE ATF NRT STATED IN  
PAGE 16 OF  
A BOSTON GLOBE ARTICLE ON 30 OCT 91 THAT QUOTE " THE ROSLINDALE CASE  
APPEARS TO FIT A NATIONAL PATTERN [THE ROCWELL BOMBING] DID NOT APPEAR  
TO BE A TERRORIST ATTACK FBI STATISTICS SHOW THE MOST COMMON TARGETS  
OF BOMBINGS ARE HOMES; BOMBS ATTACHED TO AUTO MOBILES MAKE UP NEARLY  
ONE-FIFTH OF ALL BOMBINGS IN THE UNITED STATES. "

THE FBI BUREAU OF ALCOHOL TOBACCO AND FIREARMS INVESTIGATED 25  
CASES IN MASSACHUSETTS IN 1990. DURING THE FIRST QUARTER OF 1991  
THE NUMBER OF BOMBINGS WAS 522. IF THIS IS TRUE THEN WHY DON'T  
THESE APPEAR ON THIS COMPUTER LIST.

JE HAVE HEARD FROM MR WASHOM WHOSE OPINION THAT THE 86 AND  
91 DEVICE WERE BUILT BY THE SAME PERSON BASED LARGELY ON  
ASSUMPTIONS THAT CERTAIN COMPONENTS WERE USED IN CERTAIN WAYS  
AND COMPARING THE 91 DEVICE TO <sup>THE 86</sup> A DEVICE THAT DOES NOT EXIST,  
WAS NOT PHOTOGRAPHED, NO MOCK UP MADE, NO SCHEMATIC DRAWN BY  
EXPERTS BACK IN 86 AND HAD MORE DISSIMILARITIES THAN THE FEW  
GENERAL SIMILARITIES AND WAS LESS LIKE THE ROSLINDALE DEVICE THAN  
OTHER MORE RECENT DEVICES AS DISCUSSED BY DENNY KLING.

MR KELLY STATES THAT MR T HAD A DUAL MOTIVE 1) PERSONAL - TO  
INDUCE AND CULTIVATE COMPANIONSHIP AND SEXUAL RELATIONS FROM  
TOMAS SHAY AND 2) A FINANCIAL MOTIVE, THE PROSPECT OF RECEIVING  
MAYBE SOME PORTION OF A SUBSTANTIAL AMOUNT OF MONEY FROM THIS INSURANCE  
SETTLER FROM THE PENDING LAWSUITE. FIRST OF ALL YOU HEARD THE  
TESTIMONY OF JOHN CATES THAT HE AND MR TREMULLER WERE LIVING TOGETHER  
BETWEEN OCTOBER OF 90 UNTILL HIS INDICTMENT IN DEC OF 1992, TOGETHER  
EVERY NIGHT EXCEPT JUNE 9 - 18 OF 1991, THE TIME THAT MR TREMULLER

ORIGINALLY MET MR SHAM JR. MR TREMKLER, AN INTELLIGENT, HARD WORKING MAN DID NOT HAVE TO BE WARNED TO STAY AWAY FROM SHAM JR. HE, MR. DID THIS ON HIS OWN, AVOIDING JR'S PAGER CALLS TO MR T'S PAGER. MR TREMKLER HAD NO INTEREST IN THIS MR SHAM. YOU HAVE HEARD TESTIMONY FROM AL'S FRIENDS, COLLEAGUES, AND CLIENTS WHO ARE OBVIOUSLY NORMAL, STABLE PEOPLE, THESE ARE AL'S FRIENDS.

AS TO THE GOVERNMENT'S THEORY OF FINANCIAL GAIN FOR A MOTIVE, YOU HAVE HEARD FROM FRANC C OF VIDEOCOM THAT HAD A BUSINESS RELATIONSHIP WHERE MR TREMKLER WAS 'IN' ON EVERY PROJECT THAT VIDEOCOM HAD BOTH LARGE AND SMALL. YOU HEARD FROM BILL MAEMMENA ANOTHER BUSINESS MAN FROM CSM THAT HIRED AL THROUGH VIDEOCOM TO COMPLETE A RATHER LARGE PROJECT THAT STARTED IN SEPTEMBER AND SPANNED THROUGH MARCH OF 1992. YOU HEARD OF TESTIMONY OF ED NEVADO FROM CH 25 WIXT THAT HAD KNOWN AL THROUGH BOSTON CATHOLIC TV IN THE MID 80'S THAT WAS INTERESTED IN ANOTHER UNRELATED PROJECT FOR CHANNEL 68 ALL THIS PRIOR TO OCTOBER 28 1991. IF WE TOTAL THESE PROJECTS WE COME OUT TO ALMOST 200K - A KNOWLEDGE THAT MR TREMKLER HAD PRIOR TO OCT 28 1991. WE HAVE NOT EVEN TOUCHED ON THE 20 SOME OTHER PROJECTS MR TREMKLER WAS WORKING ON PRIOR TO OCT 28 1991

FAILED BUSINESS - MR TREMKLER WAS ON THE WAY TO FINANCIAL SUCCESS HOW WAS HE TO KNOW THAT CSM WAS GOING TO PULL THE PLUG ON THE BROADCAST CENTER - HE DID NOT. THE IRS GIVES A BUSINESS FIVE YEARS TO TURN A PROFIT - MR T WAS ONLY IN BUSINESS FOR HIMSELF FOR 8

YOU THE JURY MUST ASK YOURSELF - IS THIS THE MAN THAT WOULD PARTICIPATE IN SUCH A MALICIOUS, HEINOUS ACT?

WE HEARD A UICED TAPE IN WHICH SHAM JR STATES HE BOUGHT SEVERAL PARTS INCLUDING A TOGGLE SWITCH, A BATTERY HOLDER AND SOME ELECTRICAL WIRES. WE KNOW FROM THE EVIDENCE THAT A RADIO SHACK TOGGLE SWITCH WAS USED. BUT WE ALSO KNOW FROM THE FORENSIC EVIDENCE THAT THE BATTERY HOLDER WAS NOT FROM RADIO SHACK BUT INSTEAD FROM UTABA.
