'91 LIGHT BULB - 7.5 VOLT BULB WOULD FAIL IMMEDIATELY IF USED TO TEST THE 45 VOLTS PRODUCED BY THE 5 - 9 VOLT BATTERIES AND THEREFORE WOULD BE USLESS TO BE SURE POWER WAS OFF BEFORE ATTACHING THE BLASTING CAPS

QUESTION WILL BE POSED THAT THE BULB COULD HAVE BEE USED TO TEST THE REMOTE CONTROL TO WHICH THE ANSWER WOULD BE, THE TEST FOR THE REMOTE CONTROL RECEIVER WOULD BE TO ACTIVATE THE TRANSMITTER AND OBSERVE THE SERVO MOVEMENT

'86 ANTENNA WAS ADDED ON - 75" OF GREY INSULATED 22 AWG WIRE

'86 NO MENTION HOW RELAY WAS WIRED INTO THE CIRCUIT OR WHAT TYPE OF RELAY WAS USED

NO LIGHT BULB FOUND OR INDICATION OF WHAT THE BULB WAS USED TO TEST IN EITHER '86 OR '91 DEVICE - WASKOM ONLY ASSUMES

'86 OTHER THAN ASSUMPTION, HOW DOES WASKOM KNOW IN WHAT WAY THE TOGGLE SWITCH "ARMED" THE DEVICE

'86 SIMULATOR WAS NOT OBTAINED FOR THE '86 DEVICE, THE SIMULATOR EXISTED AT MARYANNE LEACH'S HOUSE AND DONNA WANTED A WAY TO SET IT OFF. AL T DID NOT SELECT THE SIMULATOR - IT WAS THERE - AL WAS ASKED TO FIND A WAY TO SET IT OFF - AL GOT REMOTE CONTROL TO MAKE THE SIMULATOR GO OFF. TESTIMONY FROM TODD LEACH STSTES THAT SIMULATOR WAS DONNA SHEA'S. TESTIMONY FROM BOB CRAIG WAS THAT THE SIMULATOR BELONGED TO DONNA SHEA AND AL WAS INTIMIDATED INTO SETTING UP DEVICE. MOHAMMOD DIDN'T GO TO THE MOUNTAIN, THE MOUNTAIN WAS BROUGHT TO MOHAMMOD.

'86 AL WAS NOT DISCOVERED TO BE THE GUILTY PARTY BY TRACING THE REMAINS OF THE DEVICE, AL ADMITTED TO MAKING THE DEVICE FOR DONNA SHEA, AL CONFESSED. WASKOM STATES THAT I LEARNED FROM MY MISTAKE IN '86 BY LEAVING THE SERIAL NUMBER ON THE SIMULATOR SO IN '91 DEVICE I REMOVED THE SERIAL NUMBER FROM THE DYNAMITE SO IT COULD NOT BE TRACED TO ME.

WASKOM APPEARS TO BE USING REVERSE LOGIC, USING THE '91 DEVICE LAYOUT AS THE MODEL TO CREATE THE '86 DEVICE, AS AN EXAMPLE, HE ASSUMES THAT THE '86 DEVICE HAS A SEPARATE BATTERY PACK, A SEPARATE SLIDE SWITCH, A SEPARATE RELAY ASSEMBLY AND A SEPARATE RECEIVER. IN THE '86 REPORT IT IS STATED THAT THERE WERE PORTIONS OF A RADIO SIGNAL RECEIVER THAT CONTAINED ONE SIZE AA "RAYOVAC" BATTERY. I.E. BATTERY PACK AND RECEIVER WERE HOUSED IN THE SAME CONTAINER.

'86 WASKOM ASSUMES THAT THE RELAY IN THE '86 DEVICE IS A DOUBLE POLE DOUBLE THROW, HOW DOES HE KNOW WHAT TYPE OF RELAY WAS USED, AGAIN HE IS ASSUMING

'91 MAKER BOUGHT 4-AA AND 5-9 VOLT BATTERIES ALL WITH THE JULY '94 USE DATE ON THEM. WOULD THIS NOT BE CARELESS AS THE POSSIBILITY EXISTS THAT THIS PURCHASE COULD BE TRACED

'91 MAKER BOUGHT A RADIO SHACK TOGGLE SWITCH AND THE GOVERNMENT ASSUMES IT WAS JR SENT BY ME TO A RADIO SHACK ACROSS THE STREET FROM WHERE I HAD A LARGE PROJECT GOING ON. IF THE MAKER OF THIS DEVICE TOOK THE PRECAUTION TO RE-WRAP THE DYNAMITE AND USE A LATE MODEL FUTABA SYSTEM, WHY WOULD I SEND JR TO PURCHASE A TOGGLE SWITCH AT A RADIO SHACK ACROSS FROM CHRISTIAN SCIENCE WHEN THERE IS A RADIO SHACK WITHIN TEN MINUTES OF MY OFFICE. ALSO, SINCE I AM IN THE ELECTRONIC BUSINESS, I WOULD HAVE ACCESS TO ANY NUMBER OF TOGGLE SWITCHES. ALSO, IF IN '86 I USED A NON TRACEBLE TOGGLE SWITCH WHY, IF I GOT BETTER, WOULD I NOW USE A TRACEBLE SWITCH IN '91.

'86 HAND WRITTEN LANNERGAN NOTES STATE THAT THERE WAS ONE TOGGLE SWITCH THAT DISABLED THE 12 VOLT POWER SYSTEM AND THE DEVICE CONTAINED A TOGGLE SWITCH WITH AN ANTENNA WHICH WAS NOT RECOVERED. AGAIN THERE IS NO MENTION OF A SLIDE SWITCH IN EITHER THE '86 REPORTS OR IN DENNY'S AFFIDAVIT.

MY COMMENT TO LEAHY THAT A R/C IS UNRELIABLE AND THAT IT WOULD TURN ON IT'S OWN WOULD BE THE REASON FOR THE BACKUP SHORTING TOGGLE SWITCH I.E. AFTER PLACING THE '86 DEVICE ONE WOULD TURN THE SHORTING SWITCH IN THE OFF POSITION, THEN ONE COULD SAFELY REMOVE THE SIMULATOR SHORTING CAP AT ALMOST A TWO (2) FOOT DISTANCE AWAY FROM THE DEVICE AND BE FAR ENOUGH AWAY FROM THE DEVICE IF IT WENT OFF PREMATURELY.

'91 THERE IS NO MENTION OF WHERE THE FUTABA R/C CAME FROM

'91 PLACEMENT OF THE ANTENNA (IF ON THE OUTSIDE OF THE BOX) SHOWS LACK OF RADIO FREQUENCY KNOWLEDGE IN THAT THE ANTENNA COULD HAVE BEEN PLACED ON THE INSIDE OF THE BOX WITH NO ATTENUATION TO THE RECEIVED SIGNAL. IN THE RF INDUSTRY IT IS A KNOWN FACT THAT THE LOWER THE FREQUENCY THE LESS ONE HAS TO BE CONCERNED WITH LINE OF SIGHT PATH AND ATTENUATION DUE TO NON-METALLIC SURFACES.

WASKOM MAKES THE COMMENT THAT ROUND MAGNETS ARE RARE. THE SOURCE OF ROUND MAGNETS IS RATHER LARGE. '91 IF THE SLIDE SWITCH WAS FOUND AFTER THE FORCE OF A DYNAMITE BLAST, WHY WAS THE SLIDE SWITCH NOT FOUND IN THE MUCH LESSER FORCE OF A SIMULATOR BLAST - WASKOM ONLY ASSUMES THAT THERE WAS A SEPARATE SLIDE SWITCH JUST LIKE THE '91 DEVICE - BUT IN '86 IT WAS NEVER MENTIONED OR FOUND

'86 LANNERGAN'S HAND WRITTEN NOTES SAYS I SAID TOGGLE SWITCH WAS USED TO DISABLE THE 12 VOLT SYSTEM - THIS COULD BE DONE TWO WAYS 1) SWITCH COULD BE IN SERIES WITH THE 12 VOLTS SO THAT POWER COULD NOT GO TO THE SIMULATOR 2) SWITCH COULD BE IN PARELELL WITH THE 12 VOLTS AND IN PARELELL WITH THE SIMULATOR SHORTING CAP AS A BACK UP SHUNT OR SHORT SO THAT THE 12 VOLTS COULD NOT GO TO THE SIMULATOR BEFORE PLACEMENT.

'91 DEVICE MADE TO KILL
'86 DEVICE MADE AS PRANK

'91 FACT THAT THE DEVICE WORKED MEANS THAT THE SLIDE SWITCH WAS IN THE "ON" POSITION AT SOME POINT BEFORE DEVICE DETONATED. BASED ON THIS, AND THE FACT THAT THE FUTABA SYSTEM WAS TESTED AND FOUND TO GO "DEAD" AFTER 22 HOURS, IF SHAY SR FOUND THE DEVICE AT OR AROUND 1:00PM ON SUNDAY THE ELAPSED TIME BETWEEN THEN AND 12:00PM MANDAY WOULD BE 23 HOURS. IF THE FUTABA TESTS BAD AT 22 HOURS THEN AT 23 HOURS THE SERVO WOULD NOT HAVE ENOUGH POWER TO THROW THE TOGGLE SWITCH. THE ATF SAYS THAT THE DEVICE WAS PUT ON THE CAR SOMETIME SATURDAY NIGHT BETWEEN 8:00PM AND 10:PM WHICH WOULD NOW PUT THE ELAPSED TIME AT 38 HOURS GIVING THE BENIFIT OF THE DOUBT OF A 10:00 PM INSTALL TIME. GIVEN THESE FACTS, IT WOULD STAND TO REASON THAT SOMEONE WAITED UNTIL MONDAY TO TURN THE DEVICE ON. IF, HOWEVER, THE DEVICE WAS ON AND IT WAS THROWN THE ONLY POSSIBIITY REMAINS THAT IT MIGHT HAVE JARRED THE SLIDE SWITCH INTO THE OFF POSITION, BUT THIS WOULD NOT EXPLAIN WHY IT DETONATED ON MONDAY. THE ONLY OTHER POSSIBILITY WOULD BE THAT THE DEVICE WAS IN THE OFF POSITION AND WHEN IT WAS THROWN IT JARRED THE SWITCH INTO THE ON POSITION BUT NOW WE ARE BACK TO THE DEVICE BEING ON FOR 23 HOURS AND THE PROBABILITY OF THE DEVICE NOT WORKING AFTER THIS LENGTH OF TIME.

THE POINT BEING, SHOULD WE BRING TOM HOBIN IN TO TESTIFY TO THIS FACT AS WELL AS THE FACT THAT THERE WAS NO DEAL MADE OTHER THAN THE INDICATION THAT DONNA SHEA WAS THE ONE THAT I DID THE '86 DEVICE FOR. JACK LAMERE WAS ALSO PRESENT FOR THIS DISCUSSION.

WASKOM STATES THAT HE GLEANED THIS INFORMATION FROM THE QPD REPORTS AND OR THE DENNY KLEIN REPORT, HOWEVER IT IS NEVER MENTIONED IN ANY REPORT - WHERE DID WASKOM GET THIS INFORMATION FROM?
