Also why does it appear to be insignificant that the neighbors tell investigators that they saw Sr with a drab colored box comming out of the Mazda, and the Mazda is never again mentioned)

He did not personally talk to Kraft or Creavin or Sr. or Maloney. He was just relying on the ATF and BPD to configure his investigation. (Then why didn't ATF or BPD ever tell him of the neighbors observations and the fact that SR. gave Four (4) different accounts about the bomb - the fact that Tom McKernan had observed Sr. at the Z Lock place comming out of the building with "something " in his (Sr.)'s hands, and James' wife seeing Sr. with the device in his driveway, both Pirrello's seeing Sr. with a drab box walking up the driveway etc. etc. etc.)

He was about 15 feet away from the car when it began to drive away. He's not sure if the car was running the whole time or not.

(My 78 Toyota was White, many rust spots, many dents, holes where the locks should be, a two (2) foot dia. red and white decal on the hood, an antenna on the trunk, a WBCN decal on the trunk where the lock is located, blue interior, and a very noticable muffler leak that could be heard from a hundred feet i.e. one would know if the car was running)
