1991 NOV 20 AT DONNA SHAY'S HOUSE WITH MY ROOMMATE JOHN CATES, DONNA AND ~~JIM~~ JIM, EVENING. JIM ASKED ME TO STEP INTO DONNA'S BEDROOM TO SPEAK. JIM SPOKE OF HOW MARTIN COSGROVE WAS NOT THE ATTORNEY TO USE IN A CASE OF SUCH MAGNITUDE. I TOLD HIM THAT I HAD ABSOLUTELY NO INVOLVEMENT IN THE CASE AND TOLD HIM I FELT THAT I WAS JUST ONE OF MANY PEOPLE BEING QUESTIONED ABOUT THE CASE AND WAS CONVINCED THAT I REALLY DIDN'T HAVE ANY WORRIES. JIM TOLD ME THAT THERE WERE ONLY A FEW SUSPECTS AND THAT I WAS NUMBER ONE.
