

MIKE COADY

1) MET IN 1983 IN MARCH AT A PARKING LOT IN THE BLUE HILLS IN BRAINTREE MA, A MEETING PLACE FOR GAY AND BISEXUAL MALES, AND WANTED A RIDE HOME BECAUSE HIS BICYCLE HAD CONVINIENTLY BROKEN DOWN (LATER HE TOLD ME THAT THIS WAS HIS WAY OF MEETING PEOPLE) THIS MEETING WAS WITNESSED BY A DANNY CURRAN OF WEYMOUTH MA WHO HAD MET COADY A YEAR BEFORE I DID.

2) AS FOR SEXUAL CONDUCT I DID NOT MOLEST HIM AS REFLECTED IN THE ATF REPORT. 6) COADY SAYS HE DROPPED OUT OF HIGH SCHOOL. IF HE DID IT WAS NOT BECAUSE OF ME, UNLESS HE WAS KEPT BACK A YEAR OR TWO AND DECEIDED TO DROP OUT OF HIGH SCHOOL.

7) AS FOR WHO SUPPLIED THE DRUGS, IT WAS MIKE COADY THAT HAD ALL THE CONNECTIONS. ALSO, IF I WAS SELLING DRUGS TO HIM OR SUPPLYING DRUGS TO HIM WHY WOULD I BE WRITING CHECKS TO HIM. IT WAS HE THAT WAS SELLING MARIJUANNA AND COCAINE.

8) AS TO SELLING DRUGS, THIS NEVER HAPPENED. BESIDES MIKE'S BROTHER AND ONE OF MIKE'S FRIENDS I DID NOT KNOW ANY OF MIKE'S FRIENDS, AS FOR FRIENDS OF MINE, MIKE MET DONNA ON A FEW OCCASIONS, AND MET SOME OF MY GAY FRIENDS ONCE AT A PARTY IN DUXBURY. BETWEEN 85 AND 89 COADY WOULD FIND MY ADDRESS THROUGH AN EMPLOYEE OF THE PHONE COMPANY AND WOULD SHOW UP AT MY VARIOUS ADDRESSES BUT I WOULD AVOID HIM. ON 31 OCTOBER 86 I HAD MICHAEL COADY'S LICENSE RAN ON THE LEAPS COMPUTER SYSTEM WHICH GENERATED THE INFORMATION THAT HE WAS BORN ON 21 MAY 1965. ALSO I HAD CALLED THE PHONE COMPANY TO COMPLAIN THAT COADY WAS OBTAINING MY ADDRESS THROUGH AN EMPLOYEE OF THE PHONE COMPANY, SINCE MY PHONE NUMBER WAS UNLISTED, AND I WAS TOLD LATER THAT THIS INDIVIDUAL, IN THE PHONE COMPANY, HAD ADMITTED TO GIVING MY ADDRESS TO COADY AND HAD BEEN FIRED.
